The Council discussed how to make continued progress on Coordinated Water Conservation and Source Area Protection. Staff presented a draft proposal for developing a coordinated water conservation or drought plan that would take in the entire basin, as well as a draft survey, summarizing the demand management policies now in place in the different local governments in the Okanagan.

Neal Klassen exited the meeting at 1:47 p.m.

Toby Pike exited the meeting at 2:00 p.m.

The Water Stewardship Coordinator gave an update on the review of local municipality water conservation bylaws.

Toby Pike reentered the meeting at 2:33 p.m.

Council Members were asked to provide input regarding the policy objectives they would like to pursue regarding water sustainability. The proposed objectives would be brought back to the next scheduled meeting.

Discussions ensued regarding the use of effluent irrigation. Vice Chair van der Gulik advised that the Ministry of Agriculture would be conducting soil testing and Members should forward any suggested survey sites to himself.

The meeting of the OWSC broke for a recess at 2:45 p.m. and reconvened at 3:00 p.m.

The Council agreed that the Province had strong policies regarding Source Area Protection that were not necessarily being implemented. They also agreed that the definition of Source Area Protection was ambiguous.

Michelle Boshard exited the meeting at 3:32 p.m.

Dr. Sears would forward a recent news article on concerns about endocrine disrupters and pharmaceutical residues in effluent discharges to the lakes written by Judie Steeves to the Council.

Discussions ensued regarding actions the Council would be considering to undertake on effluent issues. Bernie Bauer would arrange some expert advice for the next OWSC meeting.

Groundwater is often left out of source protection considerations, and needs more regional coordination. The Council discussed ways to increase funding for the project to provide regional scope and increase the pace of the project. The Council observed that local governments should be encouraged to collect data on wells and groundwater use.

5.4 RDOS Regional Growth Strategies Water Policy

The Council received the RDOS Regional Growth Strategy Water Policy for their review. Members were asked to forward comments to Dr. Sears or to Vice Chair van der Gulik.

5.5 Consolidated Messages

The discussions with Valerie Cameron and Paul Kluckner would be rescheduled as they were unable to attend the meeting.

OWSC letterhead would be presented at a future meeting.

5.7 Mission Creek Storage

Bob Hrasko advised the Council of a pending agreement between the Ministry of Environment and Black Mountain Irrigation District allowing more water to be released out of Belgo Reservoir into Mission Creek to support fish habitat.

The Council requested additional information before recommending that a letter be sent to the Ministry of Environment supporting the release of more water out of Belgo Reservoir into Mission Creek to support fish habitat.
