#### 5. <u>REPORTS FROM STAFF</u>

#### 5.1 OKANAGAN BASIN WATER BOARD – BOARD REPORT

Dr. Sears reported that the OBWB had another session regarding strategic planning. The strengths of the Water Board were discussed and it was agreed that the Water Stewardship Council gives great value to the OBWB. She also noted that the Budget for 2007 - 2008 was passed and that there is an additional \$200,000.00 that will be added to the small grants program which will bring total monies available to the program to \$500,000.00.

Mr. Jatel reported that he and Dr. Sears had a tour of UBC Okanagan with professors and students who are currently involved in the areas of water research. Included in the tour was the opportunity to visit the labs and discuss current issues in detail afterwards. He feels very positive about the relationship between the OBWB and the colleges and hopes to continue this tour on an annual basis.

# 6. PRESENTATION(S)

# 6.1 WATER ECONOMICS

PRESENTED BY DR. JOHN JANMAAT, UBC OKANAGAN

Reference Material: <u>Water Resource Economics and Policy: An Introduction</u>. <u>W. Douglass Shaw</u>, <u>Edward Elgar Publishing</u>, 2005

Dr. Janmaat explained the definition of economics as the study of how people react when there isn't enough of one thing to "go around" - how decisions are made in the face of scarcity. He further explained how water economics affects the population as a whole in terms of valuation and incentives including the willingness to pay for protecting or increasing flow in streams, maintaining the water level in the lakes and maintaining surface and drinking water quality. He went on to say that water provides a wide range of services, that these services have measurable economic value and that people will pay money to protect or enhance these services.

# **Questions and Discussion**

Mr. Hrasko stated that B.C. is not in a position to buy or sell water and that water is not a commodity according to the water utilities of the province. It is considered an essential service.

Dr. Janmaat replied that while he understands that, the issues surrounding water value should be researched now, before there is a crisis. He went on to say this doesn't mean we have to go directly to privatization of water or treat it like a commodity.

Dr. Sears stated that in regards to agriculture water should be valued in a different way than an urban user as agriculture provides many things other than an economic product.

Dr. Janmaat replied that studies have been conducted in regards to what the population is willing to pay to have their home and property border farmland and it showed that there is much value to be gained from this, including orchards and vineyards along our roads, beautifying the landscape surrounding us. He explained that the value is more than just the crop itself.

Ms. MacDonald explained that she is a farmer in Summerland. In reference to agricultural issues we are not supposed to discuss economics as we are preserving the land to feed people. Water is a social benefit, we should move away from the idea that water has a dollar value and focus on food availability and the health and well being of society.

Dr. Janmaat explained that we have a common resource and the question is how we get the greatest value from it to society.

Mr. Jatel stated that he and Mr. Geller had met to discuss groundwater legislation and develop a document to present to the Board for its review and adoption. It includes three policies which are:

- 1. Harmonization of Regional District and municipal groundwater bylaws
- 2. Integrated Water Management Support for Provincial Groundwater Legislation
- 3. Increasing our Knowledge of Okanagan Groundwater to Sustain our Water Resource

General discussion ensued on the most effective way to present these policies to the OBWB for approval.
