1. CALL MEETING TO ORDER

5. REPORTS FROM STAFF

- 5.1 OBWB Board Report(s)
 - 5.1.1 Okanagan Basin Water Board Anna Warwick Sears

Dr. Sears updated the Council members on the Okanagan Water Supply and Demand Project. She reported that the steering committee met last week to discuss details of the project and plans for moving forward. The Water management and Use study has now been completed, as well as the Groundwater modeling pilot study in the southern Okanagan. The Lake Evaporation modeling study has also been completed. In August we will be awarding contracts for the Surface Water Hydrology and In Stream Flow modeling of the Basin. Due to delays associated with the Water Management and Use Study, the project completion date has been extended to late 2009.

She informed the Council members that Shawn Edwards, our summer co-op student, has been working on developing the Okanagan-Waterbucket website. It has been populated with material and soon we will be sending out invitations to our stakeholders to contribute articles and reports. The site addresses are www.waterbucket.ca/okw.

She also informed the Council members that a Eurasian watermilfoil report is currently being developed by staff for the Ministry of Environment to provide information on current milfoil operations including how the OBWB contributes to water quality, fish habitat and other environmental issues.

Dr. Sears explained that the Okanagan Basin Water Board approved a request from the Forum for Leadership on Water (FLOW) to endorse an ad (open letter) written to encourage the Government of Canada deliver on their commitment to a new national water strategy.

5.1.2 OBWB Response to Sustainable Water Strategy (Nelson Jatel)

Mr. Jatel reported that at the last meeting of the OBWB, July 8, draft 3.1 of the Sustainable Water Strategy was received. Comments and feedback are due at the August Board meeting to be incorporated into the final draft prior to printing. Board members voiced strong support for the strategy and the Council's efforts.

6. PRESENTATIONS

6.1 Antigone Dixon-Warren, Groundwater Specialist, Township of Langley: Groundwater Management Pilot Plan – Experiences from the Field

The Township of Langley is working with the Province to develop a water management plan under Part 4 of the Water Act to protect local groundwater resources. Approximately 50 % of the municipal water supply and 100 % of the rural supply is derived from groundwater. In addition, groundwater is an important source of stream flow which, during summer, is critical for fish and other aquatic life. Although the Township has already implemented a number of initiatives to protect groundwater, studies indicate key aquifer water levels are declining due to over-extraction. Poor land use practices also threaten groundwater quality. To proactively manage local resources, the Township's plan will provide additional regulatory tools to better manage local groundwater use, protect groundwater quality, protect healthy habitat and improve knowledge and understanding. 8. <u>NEW AND UNFINISHED BUSINESS</u>

8.1 Reservoir Lease Lots – OBWB Letter to Minister Stan Hagen [Anna]

Dr. Sears reported that the latest development in the sale of reservoir lease lots is that Stan Hagan has replaced Pat Bell as minister of Agriculture and Lands. The package sent to Pat Bell in the spring will be resent to Minister Hagan to apprise him of our stance on this subject.

8.2 BC Chamber of Commerce Water Conservation Policies [Anna]

Dr. Sears explained that the Greater Vernon Chamber of Commerce developed a set of water conservation policies which were taken to the BC Chamber of Commerce board meeting and adopted as policy for all BC Chambers of Commerce. The new policies will be listed on the OBWB website and the Waterbucket website.

8.3 WSC Members Update on Current Projects

All present council members gave an update on their current projects regarding water management.
