1. CALL MEETING TO ORDER

Dr. Warwick Sears, Acting Chair, called the meeting to order at 10:05am.

8. STAFF REPORTS

8.1 Executive Director Reports and Presentation

Dr. Warwick Sears provided an overview of the form and function of the OBWB and the three main programs conducted by the OBWB: the sewerage grant program, the watermilfoil program, and the water management program. She told the board about the benefits of sharing resources between the three regional districts.

8.1.1 OBWB Strategic Vision, Structure and Function

Dr. Warwick Sears told the board that the Strategic Vision was developed in 2007, but is reflective of the original letters patent. A strategic planning session will be held with this board in June 2009.

Dr. Warwick Sears presented Goals and Objectives to guide the work of the OBWB in 2009. As directors learn more about the projects and programs of the OBWB they can delve further into the goals and objectives and make changes if deemed necessary.

Dr. Warwick Sears presented the 2009 budget to the board. The budget was approved and adopted by the board in November 2008.

8.1.2 Executive Director's Report

Dr. Warwick Sears provided a staffing and accommodations update to the board. OBWB staff are now located at the Regional District Central Okanagan offices on KLO Road in Kelowna, and discussed staff turn-over and changes in responsibility.

Dr. Warwick Sears provided an update on the Eurasian watermilfoil program. Rototilling operations are underway along Vernon and Kelowna shorelines. Lake ice, snow, and frozen hydraulics have delayed rototilling operations on Osoyoos Lake; this work will be completed

later in the season. OBWB staff, at the request of the Ministry of Environment, is preparing a Eurasian watermilfoil management plan detailing operations and providing rationale for different practices.

Dr. Warwick Sears told the board that the Master Wastewater Management Plan is being finalized by the consultants. The plan will outline the current status of sewerage facilities in the Basin and is intended to give the OBWB a perspective on the future of the sewerage grant program.

Dr. Warwick Sears reported on the Water Supply & Demand project. The project is on schedule and is due for completion in December 2009. A more in-depth presentation on the project will be provided at the March 3 board meeting. The project has recently received notice of a successful grant award from Agriculture Canada of \$140,000, with potentially more to come.

8.2 Water Stewardship Director's Report and Presentation

Mr. Jatel provided the directors with an overview of the form and function of the Water Stewardship Council and the Sustainable Water Strategy.

The directors watched the "One Watershed – One Water" video, which was prepared for the One Watershed - One Water conference held in October 2008 to provide an overview of Okanagan water management issues.

8.2.1 Water Stewardship Director's Report

Mr. Jatel provided a memorandum updating the directors on Water Stewardship Council membership renewal and Council projects that are active and under development. Active projects include the Sustainable Water Strategy implementation, Groundwater Bylaws Toolkit, the endocrine disrupter research project, planning for World Water Day, and action on the reservoir lease lots issue. Projects under development include streamline water use reporting, regional water conservation strategy, groundwater management pilot, basin-wide drought planning, and First Nations capacity building.

A discussion ensued about the form and function of the OBWB and the Water Stewardship Council, including level of authority, issues the OBWB may want to deal with, the significant resource the Council provides the Board, funding of the Council, membership of the Council, and other groups the OBWB may want to partner with.

8.3 Office and Grants Administrator Report and Presentation

Ms. Dunbar provided an update on the Water Conservation and Quality Improvement program. The deadline for 2009 applications is February 13 and grants will be awarded on April 7. Applications are reviewed by OBWB staff and recommendations are made to the board. The board makes the final decision on grant recipients.

Director Siddon asked Ms. Dunbar what percentage of projects involves First Nations groups and what is being done to encourage First Nations' applications?

Ms. Dunbar replied that 15-25% of projects have First Nations involvement, but that First Nations groups cannot be an applicant to the program because they do not contribute to the tax base. First Nations are encouraged to be project partners.

Director Siddon stated that the OBWB needs to work harder to involve local First Nations groups.

Mr. Jatel stated that OBWB staff is exploring a First Nations capacity building initiative.

Chair Given asked if local bands have ever been asked to contribute to the grant program so they can receive funds.

Dr. Warwick Sears stated that the local bands have not been asked, but that it could be done. The Westbank First Nation contributes to the sewerage grants program.

Director Baker stated that it would mean a change in the letters patent of the OBWB.

Ms. Garcia provided an update on the current communications tools used by the OBWB and an overview of the Communications Plan being developed for the OBWB. Ms. Garcia also informed the board about recent or upcoming presentations.

Director Fairbairn stated that communication with Regional Board is very important. The OBWB must keep the momentum going with this.

Director Pike stated his strong support for the monthly Board Report.

Director Siddon requested a generic presentation be developed and given to board members and Water Stewardship Council members for their use. Director Siddon stressed the importance of communication with youth.

OBWB staff has prepared a letter to Southern Interior Local Government Association (SILGA) requesting a resolution calling for the Ministry of Agriculture and Lands to institute a permanent moratorium on the sale of leased lots on Okanagan drinking water reservoirs.

OBWB staff has prepared a template letter for local governments to send to SILGA requesting a resolution calling for the Ministry of Agriculture and Lands to institute a permanent moratorium on the sale of leased lots on Okanagan drinking water reservoirs.

9.3 BC Trails Strategy Comments

Dr. Warwick Sears explained to the board that the Ministry of Tourism, Culture, and the Arts (MOTCA) has recently released a "Draft Trails Strategy" for BC. Water managers were not consulted during strategy development and the strategy does contain references to potential impacts of trail construction and use on drinking water sources.

Interior Health has requested that the board send a letter to MOTCA that requests a strategy for protection of drinking water sources be prominently included in the overall BC Trails Strategy.

9.3.1 Comments from IH and water suppliers

Dr. Warwick Sears told the board that Interior Health, the Water Supply Association of BC, and the Lakeview Irrigation District have all submitted comments to MOTCA on the draft BC Trails Strategy. These comments were provided to the board.

9.3.2 OBWB letter to MOTCA
