4. ADOPTION OF MINUTES

4.1 Minutes of a Regular Meeting of the Okanagan Basin Water Board of May 5, 2009 at the Regional District Of Central Okanagan

5. DELEGATION

5.1 Valerie Cameron, Regional Manager – Thompson, Water Stewardship Division, Ministry of Environment and Ivor Norlin, Source Protection Officer, Interior Health Authority – Update on Activities of the Southern Interior Regional Drinking Water Team (SIRDWT)

Valerie Cameron with the Ministry of Environment and Chair of the Southern Interior Regional Drinking Water Team delivered a presentation discussing the formation and activities of the SIRDWT. Ms. Cameron provided the Board with the rationale for forming the SIRDWT, the agencies involved and the types of activities it engages in. Ms. Cameron described the current focus of the provincial government to encourage accountability and coordination, as highlighted in the Living Water Smart Plan for BC, and that the SIRDWT fits these goals well. She outlined an Issue Matrix developed by the team to address specific drinking water issues and the necessary actions to tackle them. Ms. Cameron emphasized that the SIRDWT handles broad, regional issues with policy implications in a strategic manner. The Okanagan Basin Water Board has been invited to participate on the SIRDWT.

6. STAFF REPORTS

6.1 Executive Director Report

6.1.1 AGM Draft Agenda

Dr. Warwick Sears told the Board that planning has begun for the AGM, to be hosted by the OBWB on September 18, 2009 at the Creekside Theatre in Lake Country. The purpose of the AGM is to share information on OBWB initiatives and programs with all elected officials in the Basin. It will be delivered as a workshop format.

Dr. Warwick Sears informed the Board that the Province is interested in exploring various governance models for water management and that the OBWB's Governance Manual is a timely document in light of this. She mentioned that incorporated in governance are notions of coordination amongst agencies, responsibilities of various agencies and the level of

participation amongst local agencies. Dr. Warwick Sears solicited a legal opinion on the OBWB's Governance Manual and mentioned that she was incorporating those comments before bringing it to the Board.

Dr. Warwick Sears also brought forward the idea of a social gathering for OBWB directors with Okanagan Water Stewardship Council members after the September 1, 2009 OBWB meeting. Board members are supportive of the idea but wish to wait until the OBWB meeting is held in Kelowna, a more central location than the south Okanagan.

6.2 Water Stewardship Director Report

6.2.1 Water Stewardship Council minutes

Mr. Jatel provided an update on the Water Stewardship Council meeting, held on June 11. A presentation given by Kirk Stinchcombe, Manager, Operational Policy and Planning for the Ministry of Environment on The South East Queensland (Australia) Drought Experience generated much interest; council members learned about some innovative drought response initiatives undertaken in that region of Australia. The OWSC also received a presentation from Ms. Renee Clark, Senior Water Quality Technologist with Regional District North Okanagan, Greater Vernon Water that discussed cattle impact reduction measures undertaken by Greater Vernon Water in conjunction with a variety of stakeholders, such as construction of new fencing structures and other cattle controls in the Duteau Creek watershed.

6.2.2 2009 Priority projects proposed by the Water Stewardship Council

Mr. Jatel informed the Board there are 13 project recommendations put forward by the Water Stewardship Council that are based on the Sustainable Water Strategy. These are considered priorities for the current three-year term of Water Management Program. Approvals for all projects initiated from this document, and the resulting potential external grant applications will come through the OBWB first.

Director Bauer, Chair of the Water Stewardship Council added that it is important for the Board to understand that this document is a draft and consists of project options and ideas and is meant to gauge the Board's comfort level with the types of project proposed.

Director Baker suggested that the information provided in the Priority Projects document could be used as a tool in leveraging provincial grant funds.

Director Pike suggested adding a component to the document that lists each project, the expected OBWB contributions, external funding sources and a contingency plan should external funding sources not be available.

Director Brydon agreed with Director Pike, adding that information about expected project timelines and identifying potential obstacles would be valuable.

7. <u>NEW AND UNFINISHED BUSINESS</u>

7.1 Update on water supply conditions in the Okanagan Basin

7.1.1 Current Supply Status

Director Pike provided an update on the water supply situation in the Okanagan Basin mentioning that as of June 12, 2009 the inflow to Okanagan Lake is lower than 2003 and is the sixth lowest inflow since measurement on Okanagan Lake began in 1921. He told the Board that some water systems are going to be more stressed than others depending on their location in the basin and the type of source (surface – upper elevation or valley lake, or groundwater) and because of that water suppliers are being asked to be careful about water level at their intakes. Director Pike suggested that strong conservation measures need to be implemented. The City of Kelowna has implemented a strong conservation measure for 2009 by having all City parks follow the same irrigation schedule as domestic customers when City parks are considered as agricultural connections with large allotments of water

Director Fairbairn asked about ways to ensure that individual water license holders are as judicious about their water conservation in light of low water supplies. Director Pike replied that individual water license holders deal directly with the Ministry of Environment concerning allocation. The Ministry of Environment can request that 5% of allocation be cut back in order to conserve water for in-stream uses (ecological baseflow). Director Pike explained that irrigators on an irrigation district's system are provided an allotment (volume) of water as determined by the water supplier and once the allotment is consumed the irrigation district has the capacity to turn their water off.

Director Kiss asked how water suppliers can determine long term, dependable supplies for the population increases predicted in the Okanagan valley; Director Pike responded that there will always be variable water supplies in the Okanagan but the work of the Water Supply and Demand Project is to help answer those questions as climate change scenarios will be placed in the model in addition to incorporating information on odd year and variable events.

Director Brydon asked if the Water Supply and Demand Project can provide estimates of water savings based on tangible and specific water conservation measures. Dr. Warwick Sears responded by explaining that information would be difficult to draw out for a very localized area, but likely a valley wide response could be determined.

7.1.2 Drought Planning Workshop – Memo and Draft Agenda

Dr. Warwick Sears informed the Board that the OBWB had been contacted by some provincial representatives who felt that in light of current water supply conditions and the forecasted above seasonal temperatures for the remainder of the summer that a drought planning workshop for water suppliers and local politicians would be a timely and well received event. The format of the workshop would include general information on drought planning, current water supplies in the Okanagan Basin and perspectives from local water suppliers in the morning session; and addressing specific issues when creating a drought plan in the afternoon session, using the Dealing with Drought Handbook from the province.

7.2 Okanagan Water Supply & Demand Project - Database Hosting

A memo presented by Dr. Warwick Sears detailed the data needs of the Okanagan Water Supply and Demand Project and recommended that the most appropriate agency to house the database is the Regional District of Central Okanagan.

"THAT the OBWB will host the Okanagan Water Database and associated models from the Okanagan Water Supply and Demand Project, with joint ownership and support from the Project Partnership."

"THAT the OBWB directs staff to enter into an arrangement with the Regional District Central Okanagan to house the model and database in their IT department."

7.3 Support of licensing off-stream livestock watering facilities

Mr. Jatel informed the Board that the Okanagan Water Stewardship Council, at its June 11th meeting made a motion asking that the Okanagan Basin Water Board write a letter to the Ministers of Agriculture and Lands, Forest and Range and Environment to support issuing water licenses for livestock use and to encourage provincial ministries to work together to develop a system that encourages establishing off stream watering locations to help reduce cattle impacts on the aquatic environment and drinking water quality.

"THAT the OBWB write a letter to the ministers of Agriculture and Lands, Forest and Range, and Environment in support of licensing livestock water use."

7.4 OBWB Policy regarding leased lots on upper drinking water reservoirs

The OBWB has reviewed the two draft policies originally submitted to the Board at the May 5, 2009 meeting, as a working group of four board members (Gordon Clark, Doug Findlater, Bernard Bauer and Toby Pike) and staff. During this review, information provided by Lloyd Manchester, President of the Okanagan Cottage Owners Association, and material gathered over the past six years was reviewed.

Discussion regarding the wording of policy 1a ensued, with the final whereas being considered to be presented as a universal truism in the manner it was initially worded. Director Bauer suggested amending the wording of the final whereas to read: E: The Okanagan Basin Water Board believes that the protection of water supply and quantity takes priority in the watershed.

"THAT the OBWB adopt Policy 1a – Multiple Use of Crown Land in Watersheds as amended and that the OBWB adopt Policy 2a – Disposition of Crown Lands Surrounding Drinking Water Reservoirs in the Okanagan Watershed."

7.5 Approval of the Web Based Reporting Tool Contract for the Water Supply and Demand Project

The Water Supply and Demand Project Working Group released a request for proposals to develop a Web-based Reporting Tool to communicate results of the project to a wide range of audiences. The evaluation committee recommended that a contract be offered to ESSA Technologies. Dr. Warwick Sears reminded the Board that while all costs are met through the Project budget the ESSA contract will be held by the Okanagan Basin Water Board and as such the Board must approve it as well.
