## 1. CALL MEETING TO ORDER

Chair Wells called the meeting to order at 10:06 am.

## 4. ADOPTION OF MINUTES

4.1 Minutes of a Regular Meeting of the Okanagan Basin Water Board of September 1, 2009 at the Regional District of Okanagan-Similkameen

## 5. DELEGATION

5.1 Chris Johnson, Kerr Wood Leidel Associates, presentation on Integrated Stormwater Management

Chris Johnson's presentation discussed why stormwater quality is important, outlined sources of stormwater pollutants, and provided examples of integrated stormwater management practices. He stated that many Okanagan communities continue to be leaders in developing stormwater quality programs. Strong source controls are in place for some new development areas and good educational programs are in place in some regions. He suggested that a comprehensive look at the contribution of stormwater pollutants to the lake systems in the Basin relative to sources is needed in order to set objectives and targets and assign priorities.

#### 6. STAFF REPORTS

#### 6.1 Executive Director Report

Dr. Warwick Sears told the OBWB is close to signing an agreement for NRCan Resource Adaptation Collaboratives (RAC) funding for \$358,000 over the next 3 years to support Phase 3 of the Water Supply & Demand Project.

Eurasian watermilfoil staff members will be joining the OBWB for lunch and can answer questions about details of the program and work begin conducted on the lakes.

RDOS has received funding grants for two projects upgrading community sewer and will soon be forwarding applications for matching grants from the OBWB.

Environment Canada has recently approached the OBWB to potentially enter into a funding agreement to complete spOKe, a web-portal for Okanagan planning resources. The OBWB would act as financial administrator, partnering with the Okanagan Collaborative

Conservation Program and the South Okanagan-Similkameen Conservation Program.

Chief Phil Fontaine will be speaking at the UBC-O distinguished speakers series on Oct 26 in Kelowna. Chief Fontaine is a highly respected and dedicated Canadian First Nations leader.

#### 6.1.1 Update on SIRDWT meeting

Dr. Warwick Sears attended a Southern Interior Regional Drinking Water Team meeting in Kamloops on September 14. The Team was formed to deal with interagency conflicts and address regional issues with policy implications that bridge different ministries. The OBWB was invited to participate as a local government representative. The Team is still working on their Terms of Reference with respect to local government involvement; there is some concern that the Team will have too many localized issues that may swamp the capacity of the Team.

Dr. Warwick Sears suggested that the OBWB continue to participate in SIRDWT meetings and convey issues forwarded by the Okanagan regional districts. Letters should be written to the regional districts to notify them that the OBWB is willing to provide this service.

## 6.1.2 Streamlined Water Use Reporting Tool

The OBWB received a stimulus funding grant for \$154,000 to support the development of a web-based system for water suppliers and other large water users to record how much water they use. The reporting tool will bring groundwater and surface water together in one data system and will provide lots of resources to water users, including summary reports, time series trends graphs, pie charts and bar graphs. The project will build on a complement the Water Supply and Demand Project.

A discussion ensued regarding who would participate in the reporting system, what constitutes a large water user, and characteristics of the system that will be essential to its success. Director Findlater cautioned that the data entry system must be light and easy,

must not duplicate existing systems and must not use up too much staff time for water suppliers.

Dr. Warwick Sears stated that a steering committee/technical working group would be established to help staff develop a system that is not onerous and also to determine what constitutes a large user. The project will be based on a strong partnership between the OBWB, water suppliers, and the ministries of Environment, Community Development, and Agriculture and Lands, and Fisheries and Oceans Canada, among other partners.

## 6.2 Water Stewardship Director Report

Mr. Jatel outlined two requests for action and discussion by the Board related to Okanagan Water Stewardship Council projects: funding an Okanagan water pricing study, funding a water quality source protection study. Both projects are within the approved 2009-10 budget.

The water pricing analysis will collect information on current water pricing and infrastructure cost estimates in the Okanagan. The assessment will provide a frame of reference to guide water pricing options for municipalities and other water purveyors, identify mechanisms to support payment for infrastructure, and help determine farmer's ability to pay for water.

The integrated stormwater management grant feasibility study will research the scope, costing, program demand, willingness of BC government participation, and governance issues associated with expanding the currently well utilized sewage facilities grant program.

# 6.3 Research and Communications Coordinator Report

Ms. Garcia gave an overview of the results of two surveys conducted recently by OBWB staff: a random telephone survey of 400 Okanagan residents conducted in August and a survey of local government electeds and staff that was emailed to more than 200 people and available at the AGM in September (32 respondents to date). She provided graphs comparing responses by local elected officials and the public (telephone survey conducted in August) to three questions that were asked of both groups. Responses were very similar between the residents and the politicians.

Ms. Garcia told the Directors that the survey of local government electeds and staff is still available – either in hard copy or on-line – and asked the Directors to encourage their colleagues to complete the survey soon.

Director Baumbrough requested that the survey be emailed to the distribution list again with a reminder about its importance.
