He stated that there were many major decisions made and Officers generally speaking, outstanding progress has been achieved through the Board's co-operation. The Province recently confirmed participation in a weed eradication program. He commended the Secretary-Manager for his substantial effort and dedication to the Water Board. Chairman Mr. Fleming indicated it was customary for the Board to rotate the Chairmanship between the Regional Districts annually. He opened nominations for Chairman. Mr. Stuart nominated Mr. Colclough. Further nominations were called for three times. Mr. Day moved that nominations be closed. Mr. Colclough was declared Chairman of the Board for 1976. Mayor Fleming indicated that the Chairman for 1977 would be from Vice-Chairman the Regional District of Central Okanagan. of Commerce. The letter indicated that the residents of Okanagan Falls

were in favour of lowering Skaha Lake as much as possible so they could clean up their beaches.

Mr. Colclough indicated that the lowering of Skaha Lake had been previously considered during the winter period, but it was felt some water intake freezing problems could arise. He mentioned that the Regional District of Okanagan-Similkameen Technical Committee had recently met concerning a lowering of Skaha Lake during the frost-free period, perhaps in mid-March. The Secretary-Manager had attended the meeting and indicated a lowering of Skaha Lake would assist in other weed removal techniques, i.e. in the laying of bottom barriers. This could be done easier in shallower water. If the lake could be lowered, this would help. A lowering of Skaha Lake could be limited depending on the amount of snowpack and also on the number of intakes which would require extension into deeper water or on the suction capacity of existing pumps.

The Chairman indicated that various government departments would have to be involved. The Secretary-Manager indicated that it is anticipated that the Okanagan Lake water intakes will be lowered under the Implementation Agreement to assist in lake level management. He suggested that the possibility of lowering Skaha Lake intakes be explored at the same time. This would be reviewed by the Implementation Board, however it is not expected that they could give this consideration inside the year. Mr. Colclough indicated that the lowering of Skaha Lake for weed eradication assistance should be funded under the weed eradication program.

Mr. Stuart indicated that the Water Board feels that even the raising of \$300,000 would be possible if required under the weed program. The time to move on weed cradication is now in order to stop major downstream spreading in Skaha and Osoyoos Lakes. The Water Board has the only active program going on weed eradication with the Province.

Mayor Fleming supported the objective that the Board go ahead with the program and be ready to make a reassessment if necessary for additional funding, however, the Board should make sure that the one mill levy is firmly agreed to. This could be used to accomplish the objective.

The Secretary-Manager Program | explained that the cost figures indicated for each of the methods or eradication were the present estimates available, however, should some methods prove more effective and more effecient than others once the program is underway, costs may be shifted from the least effective methods to the more effective methods. Some flexibility would exist in the program.

> The Chairman indicated that perhaps the Board could approve the overall eradication budget with the understanding that the costs could be shifted as required.

Mr. Stuart indicated that the weed eradication programs should be looked at as still under trial stages as the Board is learning something new every year on weed eradication.

The Secretary-Manager indicated the program has been circulated to the various government agencies that may be concerned such as the Fisheries Branch, the Lands Branch, and the Water Rights Branch, and he indicated that perhaps copies of the program should be sent to the major Municipalities and the Regional Districts.

During the latter part of 1975 the Province of B.C. and the Okanagan Basin Water Board agreed to undertake a one year jointly cost shared aquatic weed eradication program during 1976, for a total cost of \$200,000. In order to take advantage of lower lake levels and the absence of plant material near the water surface, it is imperative that in-the-field operations start not later than February 15, 1976 and be completed by May, 1976.

The following is a description, prepared by the office of the Water Board and the Water Resources Service, of eradication techniques to be used, costs, and scheduling:

1) Subsurface Rototilling

This method will employ the use of agricultural type rototiller heads to dislodge the aquatic weed root system which then floats to the surface. Rototillers will be mounted on an amphibious "Bombardier" vehicle to reach areas of less than 3' of water depth. A rototiller mount on existing floating harvester unit will be used to treat areas greater than 3' deep.

Rototilling methods are to be used primarily in expansive weed beds with a relatively even lake bottom free of rock and other obstructions. Two major areas to be treated with this equipment include the Northeast Arm of Okanagan Lake on both sides of the estuary of Vernon Creek, and the Kelowna waterfront from the Hwy. 97 bridge south to Mission Creek. If this method shows a good level of efficiency, without the spread of root fragments, it will be considered for use in smaller infested patches also. The period of operation will be February to May 1976.

2) <u>High velocity Jetting</u>

3) Opaque Bottom Barriers

Bottom barriers usually of polyethylene, polyvinyl or hypalon materials are placed on the lake bottom in critical areas to prevent light penetration thereby stopping plant growth. Owing to physical constraints this method can be used only on relatively small patches and where absolute control of plant growth is required before further spreading occurs. Bottom barriers must be weighted with sand.

This method will be primarily used on small patches of watermilfoil growth occuring on the North, East, and South shores of Shaka Lake; on the South end of Okanagan Lake; and on the North end of Kalamalka Lake.

Bottom barriers will be layed during the months of March and April 1976.

Herbicides would be used to a limited extent primarily in enclosed boat mooring facilities and minor spots considered to be safe.

Mr. Woodward indicated he felt that supplementary letters patent of Treatment the Board were sufficiently broad to permit the Board to set aside all or a portion of the annual requisition upon the three Regional Districts in a reserve fund. He indicated while the Water Board may establish a reserve, he was of the opinion that the reserve should be maintained as a formal reserve under the provisions of Part 7 of the Municipal Act. This would ensure that the usual Municipal rules governing reserve funds would apply to any reserve of the Mater Board. He suggested that a change in the letters patent be implemented in order to make the provisions of the reserve fund apply to the Water Board. Mayor Fleming explained that the one mill levy for waste treatment would be held in reserve until new facilities are built. After a few years experience the Board would be able to tell whether a one mill levy is adequate. The Board now has the authority to raise the one mill. The next major policy for the Board is to decide on the precise formula whereby it would distribute the mill and on the criteria whereby the communities would qualify for the Okanagan Basin Water Board funding. The Water Board would have to decide whether to use the CMHC definition of sever works or the B.C. Municipal Sewage Facilities Assistance Act. Mr. Cololough indicated that there are several definitions of sever works which the Board should possibly consider and perhaps should not consider financing all collection lines. The Secretary-Manager explained the definition of sewage treatment works as provided in Bill 88. Mayor Fleming suggested that each Regional District examine the definition of sewerage works as provided in Bill 88 - the Sevage Facilities Assistance Act - and see if the terms are suitable to be adapted into a basin-wide cost sharing formula. The region should be asked whether or not they agree to use the definition as provided under Bill 88. The Chairman indicated that if waste treatment plants only are funded under the basin-wide cost sharing formula the Board coald packaps stay under the one mill levy. However, if the complete system is funded it could cost as high as 1.9 mills. The Secretary-Manager indicated that he felt Mr. Woodward had not yet had an opportunity to study the details of the formula as proposed by the Board and therefore he was not able to give an adequate commont.

Mr. Stuart indicated that he would like direction from his Regional Board and would like to look at the finance formula constructively. He felt that a decision could not be made today. He suggested that a meeting be held with the Mator Soard and the Administrators concerned from the Municipal, Regional and Provincial levels. Poli-ticians should be present at such a meeting. The Board should say what it wants and the Administrators should be able to tell the Board how it could best be done. The Chairman suggested that Mr. Woodward be present at a meeting with the Board, the Regional Administrators and Finance Directors from the Cities. The Chairman would set up this meeting as soon as possible.

Mr. Colclough indicated that there appears to be no problem in raising the one mill but the folgaula should be examined as to how the one mill would be distributed. trative Mr. Colclough presented a chart showing a proposed administrative Structure arrangement for the structuring of the Technical Committee to the Liaison (Okanagan Basin Water Board. This would be the same as the Liaison. Committee Committee as mentioned in the letters patent. The Technical Committee would be responsible for gathering the information from the three Regional Technical Committees and would be responsible for reporting to the Water Board on technical matters. The Secretary-Manager presented a chart to the Water Board showing Implenenhow the administrative structure would be laid out under the Implementation Agreement. The Implementation Board would be responsible at the top of the structure. A co-ordinator would be hired who would then be responsible for co-ordinating all the government agencies involved. The Water Board would feed into the structure laterally passing on their comments and proposals to the Implementation Board or co-ordinator. The Liaison Committee would act on behalf of the Board.

> The Board would review the charts and consider the best form of structure.

The Secretary-Manager indicated that he felt several of the Board members had not yet seen copies of the Canada - British Columbia Okanagan Implementation Agreement. He had copies available in the final draft and could mail these out if the Board wished these

The Board had already agreed to levy up to one mill on a Basin-wide basis, however, the formula that would be used in applying the one mill had not been entirely confirmed. Mr. Moore indicated that the Department of Municipal Affairs was ready to approve any formula that was technically sound and was agreeable to all the Regional Districts in the Basin. Mr. Colclough indicated that the present formula might eventually go over one mill and this would not be acceptable under the present Letters Patent. Mr. Moore indicated that under the present Letters Patent, one mill was the maximum. The present Letters Patent dealt specifically with waste treatment only. However, Bill 38 covers the entire waste treatment cost including collection and possibly the purchase of land. Mayor Fleming indicated that the one mill levy would do the job that is required now. Possibly in five years from now the one mill may not be enough and it may be necessary to increase the levy. funds raised now could be placed into a reserve fund. He indicated the present Letters Patent suggest that the one mill levy would go to sewage treatment only, however, a formula was needed that would not require much administration. Therefore, the criteria for determining sewage treatment works for the purpose of the formula should be either the CMHC definition or the existing Bill 88 definition. He suggested that those facilities covered under Bill 88 be used in the Basin-wide formula. Bill 88 does include collection systems. A criteria that is recognized by the Province, the Regional Districts, and CMHC should be used in establishing the formula. If a municipality qualified under Bill 88 for funding of treatment facilities it should automatically qualify under the Basin-wide formula for those same facilities. If the . one mill is not adequate to cover all of these works over a time period, then it could be increased when the time comes. He suggested that the Board should not get hung up on the one mill.

The basic principle of the formula is sound and the Board mercly now had to agree whether they would use the Bill 88 definition of sewage facilities or the CMHC definition of facilities that would qualify for funding. The use of Bill 88 would take into account the retroactive funding for existing facilities. Every indication is that for the first period of several years, the one mill levy would be adequate.

Mr. Colclough questioned what would be involved with having the definition merely read "sewage treatment facilities". Mayor Fleming indicated that the Board would stay within the Letters Patent in allocating the formula. If the CMHC definition or the Bill 88 definition of sewage facilities is used, the Board could be of assistance to dispersed Municipalities which will have a tremendous burden of collecting municipal wastes. The Board now has a resolution agreeing to the principle of the formula, it merely must decide now how to apply it. Would it be through the CMHC definition or the Bill 88 definition.

Mr. Boothe could not see how Summerland would be receiving benefits under the formula for five or six years.

Mr. Colclough explained that everybody in the Basin would contribute up to one mill into a common fund and the areas placing a sewage system in could draw from the fund. Some areas may not draw directly from the fund at all, even in the future; however, they are receiving benefits from the protection of the Basin.

Mayor Fleming agreed that the total Basin would benefit from the works that will be installed even though some areas may not benefit directly and immediately. Some systems will come on stream immediately as the priority exits, others will come later. Mr. Boothe accepted the fact that some functions could not be handled on an individual area basis, but he could not see why sewage plants should be shared on a Basin-wide basis.

Mr. Moore indicated that a one mill limitation presently exists in the Letters Patent of the Water Board. The three Regional Districts would have to request a change when this limit is increased. The definition of the works that would qualify under the formula would be up to the Water Board whether they wished to use Bill 88 or the CMHC definition. The present Letters Patent of the Board indicated that only sewage treatment facilities would qualify, however, if the Board wishes this to be changed they could apply for the change in Letters Patent.

Mr. Moore indicated the Department was prepared to accept a reserve fund.

Mr. Cornock indicated that the Municipalities are now applying to senior governments for grants for sewage works. He felt this was complicating the role of the Water Board. He questioned whether the application of funds by the Board is in addition to the Bill 88 funds. He thought perhaps the Provincial share would have to be reduced by the amount granted by the Water Board. He felt that if a very small amount of funds were required for sewage treatment in any one year, then only those funds should be levied, and not a greater amount.

Mr. Stuart asked whether Mr. Cornock was speaking on his own behalf or for the Regional District. Mr. Colclough indicated that Mr. Cornock was speaking as a representative of the Regional District of Okanagan-Similkameen. Mr. Cornock questioned how far the Board could go in levying extra funds. Mr. Moore replied that as long as Bill 88 stays in place, there is no intention to reduce the amount of funding to Municipalities under Bill 88 even though a local formula is adopted. Insofar as levying money beyond what is expected in an existing year, this would depend on the Boards participation and an existing debt. The Board could participate in 1976 already even though there are no new works installed. Existing works qualify under Bill 88.

Mr. Colclough indicated that according to the existing formula, the Board would be involved in all plants and collection systems. The Board would have to decide how far its participation would go.

Mr. Fleming indicated that several communities are looking at spray irrigation options for waste disposal. Lines are required to place the water on the land for irrigation. These lines are a high cost of this tertiary treatment function. A decision would have to be made whether these costs are to be shared.

Mr. Stuart indicated that it is still not clear whether land is included in the Provincial sharing. Mr. Postill indicated that he was under the impression that it did not matter how the effluent was taken out of the Basin, the Water Board would share up to 25% of the cost beyond three mills to help in accomplishing the task.

Mr. Colclough indicated that a past resolution of the Board read that Basin-wide sharing would only apply to treatment facilities and not collection systems.

Mr. Postill indicated the funds would be used for the same end result regardless of whether the cost was for tertiary treatment, spray irrigation or collection.

Mr. Mackiewich indicated that the 25% cost sharing above three mills is what determined whether or not some smaller communities would have a sewage system or not. The 25% does not appear to be very much but is often the determining factor in making it economic for smaller communities to have a sewer system.

Mr. Cornock's second concern was whether it had been confirmed the Board would be involved in sewage treatment plants only.

Mr. Moore indicated that the present Letters Patent apply to sewage treatment facilities only. A change in Letters Patent would be required to go beyond this.

Mr. Dirk indicated that the definition under Bill 88 and CMHC allow certain trunk lines to be classified as treatment.

Mr. Moore indicated that if the CMHC definition of sewage works is used, it could probably be included within the scope of the present Letters Patent of the Board.

Mr. Stuart indicated that the Board should go back to the reasoning from the original meetings as to why it was becoming involved in the first instance in the Basin-wide formula. He felt that sight of the fact why Basin-wide sharing had been suggested has been lost. The Board had looked at a Basin-wide formula to see what could be done to accomplish the job. People who will never have a sewer line may be required to pay into the formula because every person in the Basin would derive benefits from waste treatment. Originally the Department of Municipal Affairs had wanted the formula to be over one mill, perhaps two or three mills. If a basic one mill is set now, then each Regional District will know how much the levy will be each year and this will facilitate planning. The Board felt that every person living in the Basin should pay a contribution of at least one mill. This had been agreed to. He indicated there had been no objections to raising of a one mill levy over the Basin. This principle has proven to

be sound. If the Board could tie its formula into existing legislation such as Bill 88, this would make it easier administratively. The fairest and the simplest way that the retroactive condition of the formula could be placed into operation would be through the provisions of Bill 88. The entire object of the Board's sharing on a Basin-wide basis was to benefit the lake. If the present mechanics and wording of the formula is wrong, this could easily be changed. The Board has voted unanimously on the principle. It may be necessary to change Letters Patent so that the Bill 88 definition of sewage facilities could be used in Basin-wide sharing. Land cost must be included in the total cost.

Mr. Moore indicated insofar as land costs are concerned it was still not certain how far Bill 88 would go in funding for land required for spray irrigation.

He felt if a sinking fund could be available this would be good business.

Mr. Rheaume indicated that as the original calculation sheet did not include Summerland, Peachland and other smaller communities, the mill rate would eventually reach 1.9 mills.

The Secretary-Manager indicated that when considering a higher mill rate, a time span must also be attached to when a higher rate would be required. A cash flow calculation had been done, and it was found that by using a reserve fund, the mill rate should not have to be increased beyond one mill prior to 1982.

Mr. Mackiewich indicated that the formula presently has a one mill limit. If when sharing the 25% factor over three mills, it is found that the one mill is exceeded, the amount of sharing is then cut back so that the one mill maximum is still not exceeded.

Mr. Day indicated that it would be important to consider at what time one mill would be exceeded. When the decision is made whether or not to include collectors, the reasons why the Board decides to go one way or the other should be stated.

Mr. Cornock indicated that the City of Penticton now has annual debt over three mills and asked whether it would qualify under the formula. The Secretary-Manager indicated that if a community is beyond three mills of debt it should qualify for sharing under the formula.

Mr. Fleming questioned whether the Directors in Okanagan-Similkameen were opposed to the sinking fund. Mr. Colclough indicated there was complete agreement. The only question that had to be settled was as to the distribution of the fund.

Mr. Postill indicated that the Board could now go into a levy of one mill and collect it. The basic philosophy is still intact and the formula remains simple. He suggested that the Board stay with the agreement they had made before.

Mr. Cornock questioned the extent of the amount of the reserve that could be set. Mr. Moore indicated that the Water Board would have to set up a separate reserve fund in each Regional District unless the Letters Patent are amended allowing the Water Board to hold a reserve fund in its name. He felt the only limitation on the reserve fund would be the limitation of the one mill levy in a particular year. MINUTES FROM THE MEETING OF THE COMMITTEE-OF-THE-WHOLE OF THE OKANAGAN BASIN WATER BOARD. MARCH 4, 1976, 9:30 a.m. Pg. 5.

In summing up, Mr. Colclough indicated the basic problem was; does the Water Board wish to participate in the entire facilities including collection or just treatment facilities. If the Board does go for the entire treatment and collection concept there would have to be a change in the Letters Patent and perhaps approval to go over one mill eventually. If treatment facilities only are funded, the one mill would spread over a longer period. If the fraction of sharing is reduced at a later time to stay under the one mill limit, those communities coming in later would not get as much benefit out of the formula as communities coming in first.

Mr. Postill and Mr. Stuart moved and seconded a motion

"That the Water Board accept the one mill levy today and change the Letters Patent to include collection facilities as well as sewage treatment facilities".

Mr. Stuart indicated that if just treatment alone would solve the problem, then this would be all the Board should share; however, the Okanagan Basin Study indicates that collectors are needed to solve the problem in getting sewer away from the lakes. The Water Board would only be deceiving itself by thinking it could solve the problem by funding sewage treatment plants only. The problem is bigger than this. The important thing is to get at the problem with the formula. If the Board tied itself down to a formula that did not do the job this would be a mistake. The Board has always indicated that the people of the Valley want to see something done. If something is underway and done, the people may not be opposed to an increase beyond one mill in the future.

Mayor Fleming indicated that the way the Water Board has been able to get additional funding from senior governments, was by putting up some of its money on its own first. If the Board indicates they are willing to share in secondary treatment costs and collection, it may be possible the Board may get the Province to pay the entire extra cost of tertiary treatment.

Mr. Day suggested that the Regional District of Okanagan-Similkameen discuss the formula further. Perhaps the problem is not as big as it seems. He wished the Regional District to make its concerns known. The main points of concern he felt were that the Letters Patent presently do not cover collectors. This was only a technical problem in the Letters Patent. If collector lines should not be included, then this could be decided by the Regional District.

Mr. Kenyon requested a caucus for the Regional District of Okanagan-Similkameen. Mr. Colclough agreed that a recess could be held and the problem discussed amongst the Directors of the Regional District of Okanagan-Similkameen.

Mr. Postill asked if the Administrators could give their opinion concerning the reserve fund.

Mr. Hall felt there was nothing wrong with the reserve fund, but the earning which would accrue to the fund now would be spent in future years. He questioned whether people today should pay for future works. There was a good reason to go into a one mill reserve now and the formula could be reviewed in the future.

Mr. Harrison commented that if the Letters Patent will be amended to include collector lines, that the establishment of a reserve fund should also be included in the Letters Patent at the same time. Regional Districts can establish a reserve fund now, however the Water Board could not do this directly in its name. Mr. Mackiewich indicated every organization should have some money in reserve for future expenditure.

The Chairman indicated there would be a recess over the lunch period and the Board would resume this meeting again at 1:30 p.m.

He thanked Mr. Moore for attending the meeting.

Mr. Stuart suggested that the Board reaffirm the one mill position and clearly define the works for the next meeting. He suggested that the Regional District of Okanagan-Similkameen define what should be termed the sewage treatment works under the Letters Patent.

Mr. Postill suggested that the resolution should then be reworded so that the one mill is raised this year for this purpose and the excess be placed in reserve.

Postill - Stuart

That the one mill basin-wide levy be raised in the year 1976 for the purpose of a Basin-wide sewage facilities fund.

K. Boothe voted contrary.

Mr. Tait asked what the Water Board wished the definition of sewage facilities to be. Mr. Stuart replied that the Bill 88 definition and works which are included under Bill 88 is favoured by the Water Board.

Mr. Colclough explained that this application had been withdrawn and the letter received concerning this application were written prior to the withdrawal. Progress Report "eed radicacion

The Secretary-Manager reported that the rototilling principle for weed eradication has been working well. However, there have been frequent equipment breakdowns. He indicated approximately 40 acres have been treated in the Kelowna area so far and it was unlikely that there would be enough time to treat all of the infested areas before the lake level rises.

Mr. Colclough stated that as the equipment was a new concept there were bound to be problems. He said that this year's program would have to be in the nature of a pilot project, and that next year the program would be extended through the low water season.

The Secretary-Manager showed some slides of the eradication program.

Mr. J. Tait entered the meeting.

Mr. Gordon questioned what would be done insofar as eradicating weeds near residential areas.

The Secretary-Manager informed that areas near wharfs could be treated by laying polyethylene. This would be available through the Water Board office at a nominal cost for anyone who was interested in laying their own. Larger areas near residential areas could be rototilled.

The Secretary-Manager showed slides of work that had been done by a private contractor in and upon the banks of Vernon Creek. An extensive erosion problem had been created. The work had been done without approval. He suggested a formal letter be written to the Water Resources Service to encourage regulation of this type of practice.

Fleming - Boothe

That the work done on the banks of Vernon Creek be drawn to the attention of the Provincial authorities as it is completely negating work being done on weed eradication.

CARRIED

Mr. Colclough reported that the Skaha Lake lowering program has been going quite well, with no more than half a dozen complaints. He mentioned that the laying of polyethylene will be starting in that area next week. Skaha Lake had been lowered two feet below the normal operating level for this time of the year and the present level was 1106.2' elevation.

Mayor Fleming questioned when work would be starting in the North arm of Okanagan Lake.

The Secretary-Manager informed that work could probably be starting in the area within 2 - 3 weeks.

The purpose of the meeting was to further discuss the Okanagan Basin Finance Formula for waste treatment. The Chairman reported that he had indication from the Department of Municipal Affairs that Bill 88 may be reviewed and possibly changed.

Mr. Stuart reported that Mr. Woodward indicated the 3 mill limitation on Bill 88 would be changed. Those projects which have been approved already would be protected. The Board could still proceed with the one mill levy now in existence but would have to wait for government direction before the final formula for the dispersement of funds is drawn up.

Mayor Fleming indicated the Board could still use the criteria of Bill 88 for qualification by communities under the formula. The qualification portion of the Bill may not change. Distribution of the Water Board funds would have to be made as far as they would go under the definition provided.

Mr. Stuart indicated that the Okanagan Basin Water Boards Letters Patent, as they are written now, apply only to waste treatment plants. The Board may have to stay with this definition. He expressed concern over Provincial decisions regarding waste treatment cost sharing. He felt the Province was slowly closing the door to any participation on land disposal of sewage and may be leaning more towards chemical treatment. He indicated the Province would pay for some of the cost of treatment plants, which may be the smaller portion of the total sewage treatment cost.

Mayor Fleming mentioned that initial costs of spray irrigation may be higher, but the operating costs are far less. In the long run the overall cost for spray irrigation is less. The Province would be making a mistake by trying to avoid initial high costs, but incurring larger long-run costs.

Mr. Postill indicated the Board should continue to implement the one mill levy this year; and discuss the ramifications of the formula during the year. The Board should not backtrack.

Mayor Fleming suggested that the one mill be applied and the funds kept in reserve accounts of the three Regional Districts for application to sewage treatment only. Only the tertiary stage and the weed eradication program would be funded out of this reserve. The funds should be held until the formula could be related to the Provincial model. The application of the formula should be left with the Chairman until the Province clarifies their position on Provincial waste treatment sharing and their assistance to the Okanagan.

Mr. Colclough and Mr. Simmons introduced the respective members of their Boards.

Mr. Colclough welcomed the Implementation Board to the meeting. He was pleased this would be the start of a five-year Okanagan Basin Implementation Program.

Mr. Simmons indicated the job of the Implementation Board would be to resolve as many problems as they could concerning Okanagan Basin water management. The Board has just recently come into being and has held its second meeting today.

Mr. Colclough explained the structure and function of the Okanagan Basin Water Board. He indicated the Board was a committee of the three Regional Districts within the Okanagan Basin. The Okanagan Basin Study had made a recommendation for one Regional District over the entire Okanagan Drainage Basin. However, the recommendation has been revised and instead of one Regional District, the Okanagan Basin Water Board operates on behalf of the three Regional Districts in matters of water resource management. The Board has also recently, through Letters Patent, received authority to raise a levy of one mill for waste treatment projects throughout the Basin. He indicated the Regional Districts presently have Techni-cal Planning Committees. He suggested that Technical Planning Committee personnel also be used on a Liaison Committee for the Okanagan Basin Water Board. The Liaison Committee is required to be established by the Board under the terms of the new Supplementary Letters Patent issued to the Board. He presented a chart and names of various Provincial and local government agencies who are represented on Technical Committees. He suggested the Liaison Committee be a Core Committee. Only those persons directly respons ible for various aspects of implementation need attend meetings when topics relative to their concern are discussed.

Mr. Simmons suggested that a Liaison Committee should consist of other members besides members of Provincial agencies. Local regional staff should also be involved, not just government departments. Committees tend to proliferate and a means should be found to keep the size of committees down as much as possible.

The Secretary-Manager suggested that the Liaison Committee be just a Core Committee to avoid overlap. The Liaison Committee would have to be tied in very closely with the Program Co-ordinator for the Implementation Board.

Mr. Gordon suggested that the Liaison Committee should not be firmly established until there are items on which it could work.

Mr. Colclough asked whether the Implementation Board would be responsible for only the five million dollar project on downstream works or would they be responsible in the entire area of implementation. Mr. Simmons indicated that the Implementation Board would have an interest in all aspects of the entire program. The Board would examine Water Board proposals and financing of sewage works as well.

Mr. Simmons was asked whether the Implementation Board was now officially in operation and could information be funnelled to the Board to start on the program. He indicated that the Implementation Board was in a position to start a program, but the Co-ordinator's position will not be filled until later in the summer. Temporary staff would be used for this position in the meantime. Correspondence should be directed to the Chairman of the Implementation Board. He indicated that the program for this year consisting of \$500,000 expenditure had been reviewed by the Implementation Board this morning. A start would be made on the major recommendations of the study dealing with Flood Control and monitoring. Studies and designs for the downstream structures and modification of Okanagan Lake water intakes will be initiated.

The Secretary-Manager indicated that the initial study had not included recommendation for lowering of intakes on Skaha Lake, however other problems have originated in the meantime which may necessitate a review of Skaha Lake intakes. He asked whether the Implementation Board would be in a position to review this. Mr. Simmons indicated the Implementation Board could review Skaha Lake intakes as well as Okanagan Lake intakes.

Mr. Stuart indicated the Board was interested in working closely with the Implementation Board, particularly on sewage problems and stream bank erosion. He was interested to know how the Implementation Board would approach the problems of implementation.

Mr. Booth asked what involvement the Implementation Board would have with municipal effluent discharges. Mr. Simmons indicated that the agreement calls for an improvement in municipal effluent. This would partially be done with some existing funding from Federal and Provincial Governments. The Implementation Board would be involved when concepts are presented with cost figures for funding.

Mr. Woodward indicated the Implementation Board would be involved with financing of sewage programs. Individual community programs would likely be under C.M.H.C. financing. This would then have to be cleared by the Implementation Board. If a waste treatment project emerges before the Co-ordinator is in place, this would have to be worked out in the interim by the Implementation Board. The Implementation Board was not meant to manage local waste, but it would be part of the general process.

Mr. Simmons indicated the Water Board would be responsible for the whole philosophy of improving wastes in the Basin. Consequently the Water Board would be aware of any individual community waste treatment programs to improve waste in the Basin.

Mr. Stuart indicated there was a need to have some common terminology when discussing waste treatment. He indicated various levels of government have different criteria for funding different types of waste treatment and collection works. He asked, for example, would a main line from one community to another be considered as part of the treatment works, or a collector system.

Mr. Woodward indicated that the difference in terminology for waste treatment works, and in financing criteria, originates from C.M.H.C. and provincial programs which share different items of the total works. He agreed that some form of common terminology was required, however, this would be difficult in view of the existing separate financing programs. was that the Implementation Board, representing two levels of government, and the Water Board, representing local government, could decide definitions together.

Mr. Gordon asked whether there was funding available for feasibility studies of collection and treatment facilities. Mr. Colclough indicated that usually the designated area is taxed and a feasibility study is done under the Regional District. The Secretary-Manager indicated that there was some funding under C.M.H.C. which was available for feasibility studies, particularly in areas of small population where per capita cost would be high. Mr. Woodward suggested that the Okanagan Basin Water Board, with a part of its one mill levy, could be involved in feasibility studies.

Mr. Stuart indicated that waste treatment costs in the Okanagan Basin considering tertiary treatment could be considered to be too high even with the existing funding. The Implementation Board should review this.

Mr. Tait indicated there has been some question as to what is an acceptable method of tertiary treatment. Some areas are considering spray irrigation; in other areas, chemical treatment is an option. He asked what would be acceptable to the Implementation Board. Mr. Simmons indicated that effluent discharges would come under the Pollution Control Act. This would be worked out with the Pollution Control Branch when permits are issued.

Mr. Colclough indicated that the Okanagan Basin study aimed mostly at the removal of phosphorous. There has been some criticism that nitrogen, as well as phosphorous, is a factor to be considered. Mr. Simmons indicated that at the time of the study, phosphorous was considered to be the prime cause of undesirable growth in the lake, however that would not completely eliminate the importance of any other matter.

Mr. McLaren mentioned that phosphorous was still considered to be a very important element. There would be a difference from one site to another. Nitrogen could be a factor in some areas. Mayor Kenyon indicated that the Penticton Plant seems to be doing a good job in removing phosphorous from the discharge into Skaha Lake. He indicated most of the problems appear to be prevalent in areas which do not have tertiary treatment plants. Mr. Colclough indicated that in some areas, tertiary treatment by chemical means may be the only method available. In other areas, spray irrigation may be more suitable. Whatever is the most economical method in each area should be used.

Mr. Gordon indicated that if individual waste treatment projects are left up to the initiation of each area, all the projects will not get off the ground in time. He suggested, therefore, that feasibility funds be made available soon for feasibility studies. He suggested that if 17 million dollars has been designated under C.M.H.C. to the Okanagan Basin Waste Treatment Projects, that part of these funds should be used for feasibility studies. Mr. Woodward indicated that in around about way some of the C.M.H.C. funds are available for feasibility studies once the program is underway, but the initiative has to come from the local Regional Boards or municipalities. The Water Board could only bring to the attention of the municipalities and the Regional Districts, the existence of any funds for feasibility studies. He suggested that feasibility studies could be the role of the Water Board. Money raised from the Water Board could be used to stimulate implementation of the program by providing the feasibility study. The Chairman would see if part of the C.M.H.C. funds could be designated for feasibility studies.

Mr. Woodward indicated that the C.M.H.C. funding does make provision for feasibility studies as part of the overall cost of the project. It is covered as part of the overall cost of the whole project.

Mr. Colclough indicated that he, Mr. Stuart and Mr. Postill would meet in the near future to decide on what types of waste treatment facilities would be considered eligible for Basin-wide cost sharing.

The meeting adjourned at 4:10 p.m.

The Chairman indicated that regular business of the Board could be held over until the following meeting. He indicated the main purpose of this meeting would be to review any items as required prior to meeting with the Implementation Board at 2:00 p.m. The meeting with the Implementation Board at 2:00 p.m. would largely be for organizational purposes. A brief agenda was drawn to the attention of the Board.

Mr. Postill inquired whether the 25% cost sharing would apply to the Coldstream Sewage Disposal System which involved a large trunk line to tie in with the City of Vernon's treatment facilities and spray irrigation project. He indicated that since the hook-up was essentially into a tertiary treatment facility, the cost of the hook-up should apply for the 25% cost sharing over the Basin.

Mr. Stuart indicated that the decision of cost sharing up to one mill was a Water Board decision and it would not be the decision of the Implementation Board, although they may have some comments.

Mr. Colclough indicated that since the Coldstream Trunk Line is in place of a plant that would normally have to be built, and it was part of a tertiary treatment system, it should qualify for Basinwide cost sharing. Mr. Postill indicated there was some urgency for the Municipality of Coldstream to know concerning the qualifications as they were in the process of going ahead with the project. The Secretary-Manager indicated to the Board that the definition of sewage treatment and collection facilities that would qualify under the formula have not yet been clearly settled by the Board. It had been indicated that tertiary treatment costs would be certain to qualify, but whether trunk lines would qualify remains uncertain.

Mr. Stuart indicated that the trunk line from Coldstream to Vernon should qualify for sharing under the Basin-wide formula and the "buy-in" cost into the Vernon Tertiary Plant should also qualify.

The In-Committee meeting of the Water Board was adjourned at 2:00 p.m. as the Implementation Board entered the meeting.

Re: redging This letter was in reply to the Water Board's earlier correspondence concerning a proposal to use dredge spoil from weed control operations to reclaim foreshore land. The Provincial Government indicated they would consider a dredging and land fill program only after completion of a technical and environmental study which would be a local responsibility. A study would be the responsibility of the Water Board. The only assistance the Provincial Government is offering is at the technical level. K. Boothe mentioned that changing the contour of the land would have various biological effects. The Secretary-Manager indicated that beaches have been ruined by a build-up of organic muck. If these areas were filled in with dredge spoil material new beaches would be created. Mayor Fleming said that such a technical and environmental study concerning dredging should come under the jurisdiction of the Provincial Government. He also mentioned that the Water Board does not have the facilities, nor the authority to undertake such a study, and it would be unfortunate to let this matter stand in the way. Mayor Kenyon indicated that lowering of the lake to expose more foreshore for recreation use would also be an alternative to dredging. Mr. Colclough suggested that one particular area be examined and a layman's study be prepared and referred to the Implementation Board. An area which poses few upland ownership problems should be chosen. J. Stuart suggested that the Okanagan Basin Water Board write to the City of Kelowna asking if the City could suggest a likely area for a dredging project. A. Kenyon further suggested that the Water Board write to all the Regional Districts and see if they have any areas in mind for a dredging project. rogress ≥port: Aquatic Weed Control Reporting on the weed eradication program to date, the Secretary-Manager indicated the program is behind schedule because of restricted working hours due to stormy weather, vandalism and general breakdown of old equipment. Approximately 110 acres have been treated so far in the Kelowna area. Preparations were being made to move the equipment to Vernon.

He mentioned that most of the cost of the project has been associated with research and development of equipment, rather than the operating cost. Since results of this research could be beneficial to other parts of Canada, the Federal Government should be responsible for some funding.

The Provincial Government has been given permission to experiment with the herbicide 2,4-D in a three acre test plot on the north arm of Okanagan Lake. The Water Board has written a letter to the B.C. Interdepartmental Pesticide Committee for permission to use diquat and paraquat herbicides in the Kelowna and Penticton Boat Basins this year. The Secretary-Manager indicated the B.C. Interdepartmental Pesticide Committee required permission of Dr. Clarke, Medical Health Officer before they would consider the Water Board's application.

Since most of the polyethylene layed on Skaha Beach in Penticton was lifted by a storm, the use of this material is being restricted to only very small weed patches in sheltered water.

The Water Resources Service were in the process of preparing a fact sheet concerning studies on various herbicides. The Secretary-Manager suggested that arrangements could be made for a Biologist from the Water Resources Service to be present at a Water Board meeting to present this information on herbicides. There has been some opposition from several government agencies for even the experimental use of herbicides. K. Boothe requested that information on herbicides be compiled and brought to the Board.

The Board then reviewed the summary of accounts incurred to date under the Weed Eradication Program. The Secretary-Manager pointed out the Water Board's share to the end of May was approximately \$38,000.00. There would be approximately \$90,000.00 left in the total program for next year. The Board's attention was drawn to an invoice from A.G.M. Equipment. It was recommended that a portion of this invoice not be paid owing to overcharges.

The Secretary-Manager stressed the high cost and financial risk involved in researching and developing the aquatic weed derooting equipment. Mayor Kenyon wondered whether the Water Board was qualifying for Federal Sales Tax exemption. Mayor Fleming agreed that tying into Bill 88 would be the best hope of securing Provincial assistance. It would also save the Board from having to arbitrate what were acceptable works to be shared.

Mr. Colclough indicated that it was the concern of the Regional District of Okanagan-Similkameen that if the Okanagan Basin Water Board, following Provincial sharing, were to pay the full 25% of the balance remaining on sewage treatment works after three mills, the funds in the one mill levy would not last. Therefore it was suggested that the amount of sharing be reduced to 18%, but that this sharing pertain to all sewage works rather than just treatment plants.

Mayor Fleming indicated that the Regional District of North Okanagan was prepared to accept the 25% sharing, even if the one mill in future years does not pick up the entire 25% balance. If necessary, in future years, a ½ mill could be added to the levy. The present levy of one mill based on the 25% cost-sharing formula would last to 1984.

Mayor Kenyon indicated it may be difficult to justify a two mill levy at the present time; however, a one mill levy is not likely to receive much complaint.

Mayor Fleming indicated if in future years the levy must increase, the Board may wish to make a differential between the amount levied on sewered areas and those areas not sewered. Mayor Kenyon recalled that the 25% sharing was based only on plants and perhaps trunks, however, the 18% sharing would apply to all works that are covered under Bill 88.

Mayor Fleming said that he would go back to the Regional Board of the Regional District of North Okanagan and explain the compromise wherein the Water Board would now cover 18% of all sewage treatment costs, rather than 25% of just waste treatment costs.

Mayor Kenyon felt that sharing of only 18% of the cost was a suitable concession and he would be willing to support this.

Mayor Fleming indicated that he would take this proposal back to the Regional District of North Okanagan, and that a letter would immediately be sent to the Water Board office so that plans could be made to change Letters Patent.

The Board agreed that in getting a commitment from the Province to share under the Sewerage Facilities Assistance Act the wording must be careful to include reference to the Act as effective on this date.

In summary, the Chairman suggested that all three Regional Districts inform the Okanagan Basin Water Board whether they now approve the cost-sharing formula of 18% of annual debt beyond three mills on all sewage facilities rather than just on sewage treatment works.

Mr. Stuart suggested the three Administrators draft the same request for amendments to Letters Patent to be submitted to Municipal Affairs following the concurrence of the three Regional Boards on the formula and the changes to Letters Patent. Mr. Simmons indicated that the Implementation Board felt there was a need to establish some direction as to how implementation of the sewage treatment recommendations of the Okanagan Basin Study could proceed and how the Implementation Board could assist the Water Board. He indicated that the Implementation Board had a meeting with C.M.H.C. There was a need for someone to assist in putting together the overall concept of waste treatment in the Basin. Individual elements throughout the Basin would have to be put together, cost projections made, and a schedule established. He suggested that the Implementation Board and the Water Board find a consultant to put together a summary of all the waste treatment programs in the Basin and to establish a plan for approval by financing authorities. Some of the cost to prepare the summary study could be defrayed by federal funding under the C.M.H.C. program. The Water Board and Implementation Board would end up with a program that would form a part of the total scheduling of implementation.

Mr. Quigg explained that a 50% grant for costs involved in the creation of a Regional sewage and water plan were available from C.M.H.C. There had been some question as to what is considered a Region. The \$17 million dollar allocation under the joint Okanagan Basin Implementation Agreement was designated rather loosely, however the funds would be made available as needed. C.M.H.C. did not have a firm plan for the \$17 million, however, this would not effect its availability. Grants for last years applications for feasibility studies for regional sewage plans were stalled at the moment because of dissagreement between the Province and the Federal Government as to how a region is to be defined in qualifying for such grants. He indicated that a Regional sewage plan must be in place before individual sewage plants are proceeded with. There is a list of appli-cations already made individually for grants for feasibility studies. however it is doubtful that these would qualify since they are not regional in scope. He indicated that C.M.H.C. was thinking in terms of a general plan and would approve 50% of the cost of a preparation of a general plan. He suggested that the Water Board be used as a vehicle by the three Regional Districts to present an overall plan for the Okanagan Basin as a Region. The Okanagan Basin does qualify as a region. This would help the Province and the Implementation Board in the general planning, budgeting and cost scheduling process

Mr. Stuart expressed some concern that it simply meant another study. The independent Municipalities have a common end objective of reaching outfall removal or nutrient curtailment into the Okanagan Basin. Many of the communities are well on their way to implementing construction programs to this end. The City of Kelowna has studies and will be going to referendum next spring. Similarly the cities of Penticton, Vernon, Kelowna and Coldstream have advanced their studies considerably. A decision has to be made by senior levels of government as to whether or not land will qualify for government assistance in sewage disposal schemes. The Secretary-Manager mentioned that a sketchy five-year plan indicating costs of sewage implementation has already been done, however the costs are outdated now and should be revised and a new schedule prepared. Feasibility studies have been done in most of the areas in question already and it is now a matter of summarizing these.

Mr. Colclough suggested perhaps the individual Regional Districts could summarize the programs in their District. The summaries could then be presented to the Water Board.

Mr. Colclough felt a fairly accurate schedule and cost estimate could be presented by Regional Districts. Mr. Quigg indicated that when he had met with the Board, a need was indicated to establish the basis upon which priorities could be scheduled. He indicated that some commitments under the Okanagan Basin Study have already been made by C.M.H.C. to Communities such as Vernon and Coldstream. Osoyoos was presently applying. He indicated that C.M.H.C. would provide the equivalent of 25% forgiveness for borrowing of municipal loans for sewage treatment purposes. Traditionally, C.M.H.C. has not had priorities but these are required now because of the larger demands on a limited amount of funds. He wasn't suggesting that another study be done, but rather that all the existing information and costs and scheduling throughout the Basin be pulled together in one report.

Mr. Simmons indicated that a schedule should be provided for the Basin as a whole for financial planning.

Mr. Simmons indicated that one person could bring all the material together by visiting the individual communities and Regional Districts. An overall plan could be prepared as referred to in the agreement. C.M.H.C. funding could be used under this definition.

Mr. Stuart indicated that the Water Board could make a summary study of the whole Basin and make one application to C.M.H.C. but this should not interfere with the progress of individual community sewage schemes. The projection would have to be done over a five year period.

Mr. Quigg suggested that the application form for C.M.H.C. grants for feasibility studies be looked at carefully to be certain that all the information required is included.

Mr. Simmons indicated that there are some funds available from C.M.H.C. to pay towards individual feasibility studies if they are brought together under a Regional Concept. Up to 50% of the cost of feasibility under a Regional Sewage scheme are refundable by C.M.H.C. It would be advisable to go to C.M.H.C. before the study is done to indicate that the work needs to be done. After the plan is completed it would be presented to C.M.H.C.

Mr. Quigg mentioned that he was referring to something in addition to feasibility studies done by individual consultants for individual communities. He indicated that C.M.H.C. wished to have an idea of the whole basin area. The Water Board could made a good case if the application came from the Board rather than through individual Regional Districts, since the Board covered the entire Basin.

Mr. Simmons felt the starting point would be an agreement between the two Boards to get someone in the field to pull the material together. Mr. Stuart indicated that the financial staff from the three Regional Districts could pull some information together fairly quickly. NOTES FROM A MEETING BETWEEN REPRESENTATIVES OF THE OKANAGAN BASIN WATER BOARD AND REPRESENTATIVES OF THE OKANAGAN BASIN IMPLEMENTATION BOARD, JULY 8, 1976, 10:30 a.m. Page 3.

Mr. Simmons indicated that individual municipalities should still proceed with the work they are doing and should in no way be slowed down. He indicated that the objective of the entire program was to improve the water quality in the Okanagan Basin. The comprehensive plan must meet that objective. Works must be installed to accomplish what is intended and the Implementation Board has the responsibility to see that the objective is met.

Mr. Simmons mentioned that the persons to do the study should have some familiarity with the Department of Municipal affairs in making grants for sewage treatment schemes.

The Secretary-Manager mentioned that if engineering costs are to be gathered throughout the Basin there are one or two firms in the Valley who are very familiar with most waste treatment schemes of individual communities, and these individuals could bring all the costs and scheduling together into one report.

Mr. Stuart indicated that the proposal would have to be placed before the Okanagan Basin Water Board who would have to agree whether to spend the funds on such a summary. He asked whether the Implementation Board had any funds towards such a study. He indicated that filling out the application forms for C.M.H.C. slone would involve considerable cost in getting all the required information. He indicated that a limit should be put on the costs of the study. Perhaps a figure of \$10,000.00 may be reasonable.

Mr. Simmons suggested that the Implementation Board staff would work directly with the Water Board on assembling the information. He indicated that necessary steps are now being taken to set up a staff for the Implementation Board.

Mr. Colclough and Mr. Stuart indicated that the concurrence of the Water Board would be required first and then perhaps a local engineer contacted. The name of Mr. Slee was suggested and perhaps Mr. Ken Smith would also be contacted for his knowledge on the requirements for the Department of Municipal Affairs. Mr. Simmons suggested that a representative of the Implementation Board would meet with representatives of the Water Board and perhaps an engineering consultant and a representative of C.M.H.C. to set up the terms of the study.

Mr. Stuart indicated that a meeting should be arranged through the Water Board office. He mentioned that all of the implementation works under the study depend on the existing conditions in Bill 88, the Municipal Sewerage Facilities Assistance Act, staying in place. The cost to individual communities would be prohibitive if Bill 88 sharing is not sustained. Mr. Quigg indicated that C.M.H.C. and the Province have to derive a schedule for funding not only for the Okanagan, but for the entire Province.

Mr. Simmons indicated that Mr. Leach of the Water Resources Service in Victoria could be contacted if the Board wished to explore any further details with the Implementation Board. Mr. Stuart indicated the Board would be in touch also with Mr. Quigg in Kelowna.

The Chairman mentioned to Mr. Simmons that he and the Secretary-Manager had attended a public meeting in Osoyoos where considerable concern was expressed about the lowering lake levels of Osoyoos Lake and the Zozel Dam which is in faulty repair. He asked concerning progress on this matter. Mr. Simmons indicated the matter was before the International Joint Commission. He suggested that a letter be written to Mr. Marr for a progress report.

The meeting adjourned at 12:30 p.m.

Mr. Fleming indicated some concern that residents in the Kalamalka Lake area had not yet received the pamphlet. Mr. Colclough suggested that other lakeshore areas be checked out to see whether they have received the pamphlet. Most areas had received them, however there may not have been complete distribution. It was also suggested the pamphlet be distributed to the news media.

Mr. Newroth mentioned that since the weed removal equipment had been working in the Kelowna area there had been an improvement on the beaches. He explained that herbicides had been tested in boat basins in the Okanagan system the previous year. The only herbicides which were approved for the safe use in water had been used. Everything had been done according to strict regulations. Herbicides used so far only gave control of aquatic weeds for one season, therefore tests were presently being conducted with the use of 2, 4-D in the north west arm of Okanagan Lake. He introduced Miss Pat Lim who would explain some of the details and the safety aspects of the use of 2, 4-D.

Miss Lim presented a complete report on the use of 2, 4-D for plant control. She explained that 2, 4-D is a systemic herbicide and is particularly good on broad leafed plants. It acts as a growth hormone on plants causing plants to grow very rapidly and abnormally, thereby the plant grows to death. Results have shown that it is highly effective against myriophyllum spicatum. The residues in the water and soil after the use of this herbicide are at a very safe level. She explained the effects, if any, on livestock and humans. The only harm to humans would be if the material were eaten directly. Domestic animals should be kept from sprayed areas for two weeks. Cattle had been fed on pastures sprayed with 2, 4-D and there has been no toxicity.

Considerable amounts of testing have been done with 2, 4-D on agricultural crops both in California and in England. Higher cc.centrations of 2, 4-D will effect tomatoe and cotton crops. Concord grapes are highly susceptible to damage by 2, 4-D.

Some allergic reactions to 2, 4-D have been noted in farmers applying the material, however, there are no real serious symptons. The acute lethal dose to humans would be 62 grams per man. The U.S. Public Health Service Standards indicate that not more than .1 part per million 2, 4-D should occur in drinking water for more than 2 or 3 days a year for two or more times a year.

Mr. Gordon questioned the length of time the material lingered in the soil after application. Miss Lim explained that in some isolated cases the material has been present in the soil up to ten months, but usually it disperses very rapidly and is non-toxic after about three weeks. The initial release of the material is taken up very rapidly by the plants and the residue breaks down in the water fairly quickly.

Mr. Colclough asked concerning the effects 2, 4-D had on grapes when used in the Okanagan River Channel. Mr. Newroth explained that the 2, 4-D was applied in a mist form to the Okanagan River Channel several years ago. If herbicides were to be used for aquatic weed control it would be injected as a granule and there would be no risk of spray drifting and effecting surrounding crops. 2, 4-D has been used extensively in agriculture but has not been used in B.C. water. Therefore it is being approached very carefully.

Mayor Fleming asked whether 2, 4-D would be applied only in a very carefully controlled program and if it would only be applied in areas where there would be no other effect. Mr. Newroth explained

that this would be the aim. The program would have to be undertaken in a most careful manner and would require approval of all government departments before proceeding. Mr. Booth asked how effective the herbicide was on the aquatic plant. Mr. Newroth explained that in the trials in the north arm of Okanagan Lake, the herbicide had knocked over the plant. There appears to be very little regrowth. The right amount of the material has to be used in each circumstance.

Mr. Colclough suggested that different rates would have to be applied at different locations and the material could be used around wharves and in rocky areas where machinery could not operate

Mr. Morris asked how long after 2, 4-D application to water would it be before the water could be used. Mr. Newroth indicated that it would be approximately two weeks before water could be used for drinking.

Osoyoos Lake The Chairman mentioned that he and the Secretary-Manager had recently attended a public meeting in Osoyoos concerning water quality and quantity matters in that area. He indicated that a large amount of concern had been expressed relating to the dam at the outlet of Osoyoos Lake. The present dam could not prevent the lake from dropping to lower levels which had recently been experienced. Residents were also concerned about a man-made island in the lake which was blocking flow circulation on a large stretch of beach. This matter had been previously referred to the local Lands Department, however, there has still not been any action. Mr. Colclough suggested that he would write to the Minister to take action.

The Secretary-Manager explained that the office of the Water Board had been contacted by Mr. G. Whittaker, M.P. Mr. Whittaker indicated that Mr. W. Jarvis, opposition critic from the Department of Environment, would be visiting the Okanagan on August 9th and wished to be taken on a tour of the Basin.

Clarke of the Implementation Board and Mr. Bruce Quigg, the local representative of Waste Treatment Projects from C.M.H.C. The purpose of the meeting was to see what funds the could be made available under C.M.H.C. for feasibility studies on inagan a basin-wide basis for waste treatment. basin Mr. Stuart explained that the Implementation Board had met over a week ago and had decided it would like a study done of all the waste treatment projects which are to be commenced in the next five year period under the Okanagan Basin Study Implementation Program. This would give an indication to C.M.H.C. of the timing and the funding required for scheduling these projects. The schedule would be used to calculate the cash flow requirements. This would not The schedule would hinder in any way the \$17 million dollars committed by C.M.H.C. into the study. However, the Implementation Board do have to approve all projects. If all ll priority projects for which feasi-bility studies have largely been done in the Okanagan Basin are tied together under one summary report, it is likely that C.M.H.C. could approve all ll projects at once. Bringing all the projects together under one summary would also help to tie the Provincial Government under the Sewage Facilities Assistance Act into a guaranteed future cost sharing of all the projects which will be summarized and committed for development at this time. The sug-gested cost of the summary study would be approximately \$10,000.00 and C.M.H.C. would pay 50% of the cost under the provisions of Bill C-46. If the Implementation Board approves all the projects, then the first hurdle would be met. Since the Water Board is considered Regional in scope, it would therefore qualify for the C.M.H.C. funding of the feasibility study. Individual areas are not considered regional in scope and therefore could not qualify for a grant under C.M.H.C. for feasibility studies. If the Water Board is in favour of such a summary, the terms of reference could be set up with a meeting between Mr. Quigg of C.M.H.C. and the Implementation Board. The Chairman indicated that the Provincial Sewerage Facilities Assistance Act has been tied into the Implementation Agreement. This is mentioned in two places within the Agreement. If a study were done summarizing all of the projects to be completed under the agreement, this would further lock the Province into assisting in financing projects scheduled for implementation. Mayor Fleming expressed concern that even though the Implementation Board may approve all projects scheduled for implementation simultaneously, this does not guarantee that the Pollution Control Branch, the Health Branch and many other Government Agencies will guarantee their approval.

Mr. Colclough indicated an advantage of the summary would be to provide the Water Board with updated costs and a timetable for its own planning on the financial formula.

Mr. Gordon mentioned that the Okanagan Landing Sewage Feasibility Study had been discussed several weeks ago. In Okanagan Landing alone, \$4,000.00 would be required for a feasibility study.

Mr. Stuart indicated that the feasibility study the Implementation Board wished done, did not include individual studies, but rather a general summary of the total costs of all projects throughout the basin as a region. Mr. Stuart explained that the Board would have to collate what information is produced. Individual areas may be looking at treatment on different basis.

Mr. Boothe asked whether each individual area could send in updated figures. Mr. Colclough indicated that yes, updated figures would be required from each area, however, it would take an experienced individual or consultant some time to update and gather all the figures and compile them in a summary form.

Mayor Fleming suggested that when any individual community analyzes an area bringing out the ultimate costs, these should be filed with the Board. Some areas may not be ready to move at present.

Mr. Stuart indicated that if the Board does not approve of undertaking the summary of Okanagan Basin waste treatment projects, then it should indicate to the Implementation Board the position taken. If the Board collated the figures, perhaps the amount required to do the summary would not be the \$10,000.00 suggested figure. Perhaps it could be done for much less. However, an answer should be provided to the Province. The Board would be in a better position to lock the Province into cost sharing if the Basin projects are treated as a whole.

The Secretary-Manager indicated that if there is a firm plan and priorities schedule laid out that the \$17 million dollars which has been indicated in the Okanagan Basin Study Report would indeed then be allocated to the Okanagan Basin as a priority area. Presently there is no firm schedule for allocation of C.M.H.C. funds throughout the Province.

Mr. Gordon asked if there was any indication that if all the areas are brought under the Okanagan Basin Water Board for study, would C.M.H.C. then pick up the entire cost including the cost of individual feasibility studies. Mr. Stuart replied that there was a good possibility that by doing a study throughout the Basin that the C.M.H.C. could also cover some of the cost of providing feasibility studies of individual areas done by the separate regions, but forming part of the comprehensive basin-wide plan.

Mayor Fleming asked if the Board was then considering collection of all the studies to get back 50% of the cost incurred on all the feasibility studies.

Mr. Stuart replied that an attempt should be made to recover all the costs of all feasibility studies. Once the summary is written up the Board should get clear terms of reference before proceeding and a cost estimate of the study should be done before proceeding and the report made back to the Water Board. Mayor Fleming agreed on the basis of the recommendations from Mr. Stuart that the Board should proceed. He suggested that the three Regional District advisors meet to get a consensus on the wording and that the same resolution be forwarded by each Regional District to Victoria for approval.

uatic Led Report The Secretary-Manager presented a verbal resport on the joint weed eradication program and on a recent visit to several aquatic weed infested areas in the U.S. He explained that the amount of weeds presently being eradicated by mechanical means could not keep up to the amount of new area being infested each year. The battle could not be won by using mechanical methods alone. It was obvious that another method of control, mainly the use of 2,4-D would have to be implemented along with the mechanical program.

Mr. Colclough asked if 2, 4-D herbicide was being used in the Tennessee Valley to control this type of weed. The Secretary-Manager informed that the Tennessee Valley spent nearly one million dollars this year alone in the application of 2, 4-D.

Mr. Postill stated that if 2,4-D is the best method of control, why is the Water Board not pushing the use of it here to fight the weed problem.

The Secretary-Manager explained that several Government agencies including the Fish & Wildlife Branch and the local Health Unit did not favour the use of 2, 4-D.

Several slides and a narrative presentation of the following was made:

- derooted aquatic weed areas in Kelowna and Vernon compared to previous year.
- 2,4-D test plot area in the north arm of Okanagan Lake.

The Chairman stated that from the knowledge that has been gained a new aquatic weed rototilling unit based on the principles satisfactorily tested to date should be built and used to capacity next year.

Mayor Boothe asked if the machinery that is operating now is doing the right job.

The Secretary-Manager informed that it is the only known way to de-root the weeds, and even with two or three machines, the growth rate of Eurasian watermilfoil is so rapid, that it would only be possible to keep the main beaches clear.

Mr. Stuart suggested that the Okanagan Basin Water Board invite the Premier and his Cabinet to a meeting to discuss the future of the eradiciation program and that the local government should not have to cope with this problem, since it is primarily a Provincial jurisdiction.

The Chairman mentioned that a call had been received from B. Marr regarding a meeting held recently in the Premier's office and that the Secretary-Manager, after short notice, had attempted to attend the meeting, but was unsuccessful due to cancellation of air traffic owing to bad weather conditions. It was indicated at this meeting that a local advisory committee be established to review the matter of weed eradication. The Chairman suggested that further discussion of aquatic weed eradication policy be held "In Committee".

Mayor Fleming stated that the Chairman and the whole of the Okanagan Basin Water Board should have been given more notice for the meeting in the Premier's office. He felt that much of the work by the Board had been ignored by the Premier's office. He further stated that he is prepared to move for the disbandment of the Okanagan Basin Water Board and have the Provincial Government take over sole responsibility for the aquatic weed problem unless there is a favourable response from the Province.

Additional government funding will be needed in the future for cleaning up the Basin. To date the only additional funds made available have been through the Water Board's own one mill tax levy. In order to succeed he felt the Water Board should be enlarged to include every elected Regional and Municipal Govern- ment, thereby enabling the Water Board to have greater political strength in dealing with senior levels of government. He said the mechanics of such a restructuring could be worked out later.
	Mayor Boothe felt it would be cumbersome to have every Mayor repre- sented on the Water Board.
	Mayor Postill felt that the North Okanagan municipalities were well represented on the Water Board. He indicated there was an under- standing that Mayors from the three major urban centres were auto- matically appointed to the Board if they were on Regional Boards. He commented that Mayors of all municipalities within the Basin are invited to Water Board meetings. Mr. Stuart agreed but added that observers were not entitled to vote. It would be best if municipal- ities could be present to vote on problems directly affecting them.
	Mr. Dooley stated that along with the weed and sewage problems, other problems would have to be dealt with. He suggested there was a par- allel situation existing with the Greater Vancouver Sewage and Drain- age District and perhaps a Committee should be set up to look at this

Mayor Fleming reported that Dr. Peter Newroth, Biologist, Water Resources Service, had presented an excellent submission regarding the herbicide 2,4-D to the Regional Board of the Regional District of North Okanagan. He was concerned, however, that Dr. Newroth was instructed by his superiors to give a confidential report to the Regional District of North Okanagan. Mayor Fleming felt that this information should be made easily available to everyone. There would probably be no public opposition to 2,4-D if the basis for its safe use could be made public. The Province has total jurisdiction in this regard.

The Chairman agreed that the general public do not have all the information necessary to make a decision as to whether or not 2,4-D should be used. He said that B. Marr, Deputy Minister of Environment, has assured that if it were decided to go ahead with the use of 2,4-D there would be public information meetings throughout the valley.

Mayor Fleming indicated that if this commitment could be obtained in writing, the City of Vernon would approve the use of 2,4-D.

Mr. Day indicated that when the Water Board met with the Provincial Cabinet on September 29th, the Minister of Environment assured that all the information concerning the herbicide 2,4-D would be made available to the public. He suggested that the Water Board write to the Minister of Environment asking him to make technical people and information available.

Mayor Fleming felt that if the Province seriously wanted to make an agreement with the Board for continued provisions as found in the Sewerage Facilities Assistance Act, this could legally be done without legislative problems. The terms of the agreement could be made and written into Letters Patent.

They have agreed, however, that when the Senior levels of government make public all scientific information and recommendations on the use of 2,4-D as it relates to weed eradication in the Okanagan Basin, they would be prepared to reconsider their present position. The Secretary-Manager indicated that the Water Resources Service was in the process of making information available to the public through libraries in the region as soon as possible.

Mr. Day asked whether the Province would now permit their professional personnel to speak publicly.

The Secretary-Manager indicated that the Okanagan College and the Registered Nurses Association are co-sponsoring a seminar on 2,4-D and aquatic weed control on December 6th, and that a Biologist from the Province would be one of the panel members.

Mayor Boothe expressed concern that the Secretary-Manager would also be participating as a panel member in the above mentioned seminar. He felt such a seminar would only create further debate and controversy over the proposed use of 2,4-D. He therefore moved that the Secretary-Manager not attend the seminar.

Mayor Fleming suggested that the Water Board should be present at the seminar to enhance inform tion, but not to make a judgement on the issue at this time.

Mr. Stuart felt strongly that the Secretary-Manager should attend the seminar and speak on the topic. Water Board technical knowledge should be made available. By not attending the seminar, the Water Board would only be repeating earlier Provincial restrictions on public appearances of technical people.

The Chairman indicated a motion had been made by Mayor Boothe, and a seconder was required. Mayor Fleming seconded Mayor Boothe's motion as follows:

Boothe - Fleming

That the Secretary-Manager not attend the seminar on 2,4-D and aquatic weed control to be sponsored by the Registered Nurses Association and Okanagan College on December 6, 1976.

THE MOTION WAS DEFEATED

Speaking concerning the motion the Chairman indicated that information would be made available to the public through a series of open meetings following the report of the three man advisory committee on the use of herbicides.

Mr. Stuart suggested that erroneous statements made during open meetings such as the December 6th seminar should be corrected at the seminar, otherwise it is difficult to convince the public after presentation has been made in the media.

Mr. Day agreed that the Secretary-Manager should represent the Okanagan Basin Water Board at the seminar and that the Board should not place restrictions on employees regarding the presentation of technical information to the public.

Mayor Boothe's concern was that the seminar might become a forum for emotional outbursts as had occurred at a recent Summerland meeting.

The Secretary-Manager explained that he would simply present the history of the weed problem at this seminar, and would not be involved in a 2,4-D debate.

Mayor Boothe inquired concerning establishment of the dental plan which had not previously been presented to the Board. Mr. Stuart explained that owing to accounting procedures the staff of the Water Board are on the same payroll as staff from the Regional District of Central Okanagan. Consequently Water Board staff were included in the Regional District dental plan. It was agreed that this item should have been brought to the attention of the Water Board.

Kenyon - Day

That the dental plan be adopted.

Mr. Stuart left the meeting at 4:00 p.m.

Mayor Boothe asked whether salary increases were within the anti-inflation quidelines.

The Secretary-Manager explained that salary increases were within the 8% to 12% increase allowed by the Anti-Inflation Board. The increase in the amount budgeted for salaries was largely due to provision for a full time rather than part time secretary. The increase was not entirely a result of increased salaries.

Fleming - Kenyon

That the 1977 Provisional Budget for the Okanagan Basin Water Board be received and ratification be made a. the next meeting of the Board.

1977 Aquatic Weed Eradication Program

The Secretary-Manager explained that the Provincial Governmen' was awaiting a report on 2,4-D from the three man Advisory Committee before proceeding with any plans for weed eradication next year. He felt that unless preparations for next year's program are started immediately, nothing would be done on time for weed eradication next season. The Province should proceed with a contingency plan. Approximately \$80,000 was left in the joint Provincial - Water Board eradication program for 1977. He asked if the Water Board wished to use this balance of funds to purchase with the Province a further two pieces of equipment which would be required for weed control regardless of whether or not 2,4-D is used. The Province would then have to assume all operating costs as the joint weed eradication fund would be expended.

Mayor Fleming suggested that the Board agree with the Provincial Government on a weed eradication program for 1977, using the balance of funds in the joint program for capital. The Province would then have to assume operating costs. The Okanagan Basin Water Board could assist in administrating the program and arranging contracts. He also suggested that the Okanagan Basin Water Board endeavor to secure the Provincial Government's support to obtain funding from the Federal Government. The Board should proceed to arrange for equipment with the \$80,000 remaining in the joint weed eradication fund. The Secretary-Manager mentioned that if the Province decides not to use 2,4-D it would appear that a technique using harvesting followed by rototilling would have to be used during the 1977 season. It would be necessary to purchase a harvester and fabricate another rototiller. Time was limited and the equipment would have to be ordered almost immediately.

Summarizing the above, the Chairman suggested: (1) that the Board approach the Province for concurrence on spending the remaining \$80,000 on additional equipment purchase, (2) that the Province assume all operating costs during the 1977 season with administrative assistance from the Water Board, and (3) that the Province approach the Federal Government for additional funding.

Fleming - Kenyon

That the Okanagan Basin Water Board approach the Provincial Government for concurrence in spending funds remaining in the joint weed eradication program on capital equipment, and that the Province assume all operating costs for weed eradication in 1977 with administrative assistance from the Water Board; and that the Province formally approach the Federal Government for additional financial assistance; and that the Secretary-Manager be authorized to proceed with plans on this basis. A Board meeting could be called if there is any impedance.

CARRIED

Other Business

Mayor Kenyon presented a letter he had received concerning the use of clams for aquatic weed control in the Nelson area.

He also suggested that a study be made which would indicate relative amounts of nutrient loading to the lake from various sources including septic tanks, feedlots and other sources. He was particularly interested in the Kaleden and Okanagan Falls area. The Secretary-Manager indicated that a certain amount of this type of information was available under the Okanagan Basin Study reports. It may require updating. A small amount of monitoring was currently being carried out under the Implementation Agreement.

Kenyon - Dooley

That the Water Board request the Implementation Board to undertake an updating of information concerning the sources of nutrient input to the main valley lakes.

CARRIED

Mayor Kenyon mentioned that residents of Skaha Lake were inquiring whether Skaha Lake would be drawn down again next year. Draw-down last year had given lakeshore residents a chance to clean beaches and repair water intake pipes. The Secretary-Manager indicated he has not heard of any plans to lower Skaha Lake again this season. Mayor Kenyon suggested the Water Resources Service be requested to look into this.

Kenyon - Dooley

That the Okanagan Basin Water Board request the B.C. Water Resources Service to look into the possibility of lowering Skaha Lake in 1977.

Mayor Kenyon, in referring to the City of Kelowna's Wastewater management plan, noticed that the control of phosphorous into the lake would not be achieved until a late future date. He wondered if the City of Kelowna would consider temporary tertiary treatment until their long term plan is initiated; provided that short term measures do not exceed \$50,000.

Mr. Day indicated that a tertiary treatment plan had been presented to the City of Kelowna several years ago and was turned down by City Council.

Mayor Hindle suggested that Alderman Day present this proposal to the City Council of Kelowna after the New Year.

The meeting adjourned at 4:45 p.m.
