Mayor Kenyon nominated Mr. Stuart.

Chairman

Mr. Stuart noted it has been customary to rotate the Chairmanship between the Regional Districts annually. He wondered if the Water Board had reached a time where this policy should be changed. Since the Chairmanship was to be filled from the Regional District of Central Okanagan this term, he suggested the opportunity be made for the Chairman to be elected at large from any Regional District.

Mayor Boothe agreed and seconded the motion that Mr. Stuart be Chairman.

Mr. Colclough stated the policy of rotating the Chairmanship each year has been a gentlemen's agreement. Mr. Stuart's suggestion should be recorded and perhaps at the first meeting of the Water Board next year, the Board could, if desired, elect a Chairman from any Regional District.

B.Nilsson Ok.Labour Council 1. Letter of December 4, 1976 from B. Nilsson, Chairman, Okanagan Labour Council Pollution Committee.

The letter stated that the Okanagan Basin Water Board should not become involved in a weed management program either administratively or financially as this was a Provincial problem and the Province must assume full responsibility for the condition of the lakes. It further stated that if the Okanagan Basin Water Board and the mass of citizens in the valley joined in a popular demand calling for the Provincial Government to take immediate and meaningful action on the weed problem, there would be no doubt that enough political pressure could be brought to bear upon the Government that it would implement and provide full financing of such a program.

Mr. Colclough indicated the Water Board entered into a cost sharing agreement with the Province for a weed control pgoram in 1976-77 due to the urgency of the situation. He mentioned that when the Board presented its brief to the Cabinet last summer, the Board had definitely indicated that they regarded this as entirely a Provincial problem.

Mr. Stuart indicated that after four to five years of urging the Provincial Government to accept total responsibility, the Board finally received a partial commitment to a jointly funded aquatic weed control program. It was still hopeful the Province would assume full responsibility for aquatic weed control.

Mr. Colclough explained the origin and nature of the aquatic weed control agreement with the Province for Mr. Nilsson.

3. Letter of December 14, 1976 from P.M. Brady, Director, Water Investigations Branch.

Mr. Brady enclosed the final report on the alum treatment experiment on Wood Lake entitled "Evaluation of Alum Treatment as a Method to Upgrade Wood Lake Water Quality" by B.C. Research Vancouver, B.C. The letter indicated results of the alum experiment were discouraging and consequently treating Wood Lake with alum to improve its quality was not recommended. The Water Investigations Branch now had two proposals before the Okanagan Basin Implementation Board for funding consideration. Both proposals were in an attempt to gain a better understanding of the self-cleansing mechanism in Kalamalka Lake, with the objective in mind of gaining more confidence with the alternative which would upgrade Wood Lake by mixing Wood and Kalamalka Lakes.

J. Nielsen A letter dated December 9, 1976 from the Honourable J.A. Nielsen, Re: Aquatic Minister of the Environment was received. The letter was in reply to a Water Board letter of November 16, 1976 concerning scheduling of this season's aquatic weed control program. The Board had urged the Department of the Environment to proceed with mechanical aspects of the aquatic weed control program while waiting for a decision from the Advisory Committee on the use of 2,4-D.

B.E. Marr A letter dated January 12, 1977 from B.E. Marr, Deputy Minister of the Environment was received. The letter was regarding the Board's ering of request for a lowering of Skaha Lake in the spring of 1977. Mr. Skaha Lk. Marr advised that a limited draw-down would be feasible, at least to the normal minimum level of 1107.6 feet. Draw-down below this level could be entertained only if the Okanagan Basin Water Board were prepared to provide the public with appropriate warnings of lake lowering and to reimburse home owners for any damage that might be attributable to lake levels below 1107.6 ft.

> Mayor Kenyon enquired as to what level Skaha Lake was drawn down to last year. The Secretary-Manager indicated that it was drawn down approximately two feet below the normal minimum level of 1107.6 ft. If Skaha Lake was lowered one foot below the normal minimum level, a water intake problem would not exist. A lowering of Skaha Lake this year would not aid in aquatic weed removal but would aid residents in beach clean-up.

Mr. Colclough suggested the Department of the Environment be request ed to lower Skaha Lake to a level of 1106.7 feet which is only one foot below the present minimal operating level.

Mayor Kenyon suggested that the lake be drawn down to the same level as last year, subject to the availability of water supply.

Mr. Stuart noted that reimbursements to home owners for any damage that might be attributable to lake levels below 1107.6 ft. would be the total responsibility of the Water Board, whereas last year it was a joint responsibility. He suggested that a letter be written to the Minister of Environment pointing out that this lake lowering program was very beneficial to the lakeshore owners last year and that the Province should take a more active part in this regard.

Mayor Kenyon encouraged the Board to do a systematic investigation of sewage effluent pipes when the lake would be lowered. Mr. Stuart suggested that the Water Rights Branch could take an inventory of water intake pipes at this time also.

If Skaha Lake was to be lowered it would likely be during the period between mid-March and mid-April.

The Board reviewed an application for a right-of-way by Inland Natural Gas for a pipeline crossing of Okanagan Lake north of the floating bridge. It was noted the right-of-way would have a maximum width of 200 ft. and the pipeline will be buried to a maximum cover of 6 ft. until a minimum water depth of 30 ft. is reached and beyond that depth the pipeline will lie at the lake bottom. The City of Kelowna and the Regional District of Central Okanagan have already granted their approval for this right-of-way.

Represen- Mayor Kenyon, in referring to a letter of January 13, 1977 from the ation on City of Kelowna to the Minister of Municipal Affairs requesting Water Bd. direct representation of all Mayors of Cities within the Okanagan Basin to the Okanagan Basin Water Board, was curious about the City of Kelowna's request in this regard. He felt members of the Board from the City of Kelowna had done a good job on the Water Board to date.

> Mr. Stuart indicated the City of Kelowna was seeking a direct representation on the Water Board. Under present arrangements, appointments to the Board from the City are made through the Regional District.

Mayor Boothe indicated if all the Mayors are appointed, the Board would be large and cumbersome.

Mrs. Clark stated that the City of Kelowna was very disappointed that no further credence was given to the request of the City of Kelowna to include the Mayors on the Board. She stated that the City of Kelowna was the largest Municipal financial contributor to the Water Board, but that they did not have direct representation on it. She said there was no implied criticism to the Directors on the Water Board, but that the Directors from each area were appointed through the Regional District and were not a direct representative from the Municipality.

Mr. Colclough indicated that the Mayor of any City has the option of being on the Board by standing for election to a Regional Board. Mayor Hindle agreed that he did have this prerogative and was also very concerned regarding the increased size of the Water Board if all the Mayors were appointed. He felt that this was basically a communication issue. However, he would still support the present recommendation by the City of Kelowna.

Ok. Basin Implementation Co-ordinator The Secretary-Manager indicated that a Co-ordinator for the Okanagan Basin Implementation Board has now been named. He is Murray Thomson, who was also Co-ordinator for the Okanagan Basin Study.

Mr. Gordon felt the Water Board should continue to pursue the Federal Government for funding of aquatic weed programs.

nnens: loposed Aquatic Weed Removal Machine Mr. Stuart, in referring to the Committee-of-the-Whole minutes of December 2, 1976 mentioned that an amendment should be made indicating that if a technical meeting were to be held with Mr. Jennens, those in attendance would sign the minutes of such a technical meeting.

Mr. Stuart explained that Mr. Jennens was reluctant to discuss any technical details concerning his proposed aquatic weed removal machine as patent rights were pending. It became apparent that no government agency would guarantee a machine that had not been available for study. A meeting had been arranged for Mr. Jennens and technical staff of the Water Resources Service and other government agencies, but Mr. Stuart felt this meeting should be cancelled in view of the fact that he thought perhaps a different approach should be taken to this type of situation. He therefore contacted the Premier with the suggestion of the Province sponsoring a contest for a weed removal machine, which would meet a set of specifications to be outlined by the technical people of the Departments concerned in the Provincial Government. A letter had been written to the Premier suggesting the contest. A prize of about \$100,000 should be considered. A contest would relieve the Board of many separate applications for funds.

Mayor Kenyon asked if Mr. Jennens was in favour of such a contest. Mr. Stuart replied that he was, and also that the Premier received this proposal favourably.

Mr. French indicated that Mr. D. Simpson had also approached him expressing his interest in contracting a machine to the Okanagan Basin Water Board.

Mayor Boothe suggested that the Water Board support Mr. Stuart's idea.

The Secretary-Manager outlined some of the weaknesses in using mechanical means for aquatic weed control. The basic problem of costs, storms, varying lake bottom and breakdowns would apply to any mechanical method.

Mr. Gordon cautioned the Board with respect to future proposals from individuals in this regard. He suggested that in the future the Board should not accept any briefs or proposals from individuals unless these are offered voluntarily, as legal complications could arise.

Mr. Stuart stressed that the Province, not the Board, should be responsible for the contest.

Budget

1977 The Secretary-Manager indicated a calculation error existed on the Provisional copy of the budget as presented during the last meeting. Under full time salaries the amount should be reduced to read \$32,290 rather than \$32,701. Anti-inflation Board guidelines provided for wage increase during 1976 ranged from 8% to 12%. The range for 1977 was from 6% to 10%. Salaries indicated on the 1977 Provisional Budget reflect increases of 10% over 1976.

> Mrs. Clark requested a breakdown of the R.D.C.O. requisition of \$298,838 indicated on the provisional budget. She wished to know what portion of the Regional District requisition would be allocated to the one mill reserve fund and what portion would be allocated to The Secretary-Manager explained that the allocation administration. from the requisition would be in proportion to the amounts shown under the expenditure column. After deducting amounts budgeted for the reserve fund and aquatic weed control, \$43,000 was left for administration.

Mr. Stuart indicated that a breakdown of allocations has been done under each Regional District budget.

Other Business

The Secretary-Manager mentioned that at the last meeting of the Water Board it was decided that the remainder of the funds in the aquatic weed control program could be allocated to the purchase of two new pieces of equipment provided that the Province would assume all operating costs. A reply to this proposal has not been received from the Province. In the meantime, price changes indicate that with remaining capital in the joint weed eradication program, only one machine could be purchased and the balance could be spent on operating costs. The existing machine could be used as well. Further discussion ensued concerning the expedition of remaining funds under the weed eradication program for 1977.

Mr. Gordon suggested that tenders be called for contractors to do much of the work thereby eliminating costs of new equipment. The Secretary-Manager indicated there were no contractors available with weed control equipment.

She indicated that more information would be available shortly.

Lowering of Skaha Lk.

B.E. Marr: 5. A letter dated February 14, 1977 from B.E. Marr, Deputy Minister of the Environment was received.

> The letter indicated that, owing to an unusually light snowpack, releases from Okanagan Lake this year will have to be kept as low as possible and therefore any lowering of Skaha Lake will have to be a very gradual process. By reducing the outlet from Okanagan Lake to 50 c.f.s. and maintaining a 200 c.f.s. discharge from Skaha Lake it would take about 40 days to lower Skaha. The Department of Environment was proposing to commence lowering of Skaha Lake on or about March 20th at an anticipated rate of about half an inch per day to elevation 1106.6 feet. This elevation would be reached by May 1, which is close to commencement of the irrigation season.

The Secretary-Manager indicated that 1106.6 feet elevation is approximately one foot higher than the lowest elevation reached last year.

Director Kenyon questioned if this gradual and minimum draw-down would be worthwhile. Director Colclough indicated that such a gradual draw-down would not allow the lakeshore owners any length of time to do a reasonable beach clean-up. In view of the drought conditions, Director Boothe was opposed to a draw-down of Skaha Lk.

E. Clark and S. Fleming entered the meeting at 2:20 p.m.

The Secretary-Manager explained that the flow would remain constant out of Skaha Lake at 200 c.f.s. and the outlet from Okanagan Lake would be dropped to 50 c.f.s. Verbal Report: Meeting with Environment Minister March 4/77 The Chairman reported on a meeting that had been called on March 4 in Victoria by the Minister of Environment. The meeting was attended by the Chairman, Director Colclough, Director Postill and the Secretary-Manager. A written document had not been received from the Minister, but he indicated the Provincial Government was prepared to undertake a comprehensive aquatic weed control program. The Province would co-ordinate and run the program. The Province would provide most of the financing and would hopefully eradicate the weed to the point where it would be at a housekeeping level, then local government would assume responsibility. The Minister indicated that communities in the Basin would have to agree to the eradication methods before a program could be carried out. A program would not be forced on local communities.

Director Colclough indicated the Minister presented an organizational chart outlining an administrative structure for the program. The only financial participation of the Water Board would be to pay the wages of two employees. The Chairman mentioned that many of the materials purchased, labour hired, and contracts made would be through the Water Board office to expedite the program. The Province would reimburse the Water Board for all expenditures made. The Board would only be responsible for hiring one or two staff to help run the program. The Provincial share of costs would be sizeable.

The Chairman indicated he had asked the Minister, that once a written program has been prepared, that a meeting be held in the Valley with elected representatives. It was also suggested that once the second report of the three-man advisory committee concerning the use of herbicides was available, that it be released in the valley by the committee.

The Secretary-Manager indicated that the Province wished to have an answer from the Water Board concerning the aquatic weed program proposal as presented in principle.

Director Fleming suggested that a letter be written to the Minister of Environment thanking the Provincial Government for co-operation and proposed financial support of the aquatic weed program, and that the Water Board agree to this program in principle subject to confirmation in writing.

Director Gordon questioned the advisability of leaving the option open for some communities not to participate if they desired not to have weeds removed. He stressed the importance of having a complete control program throughout the Basin otherwise weeds would spread from untreated areas to treated areas. The Chairman indicated that local communities would have some say in the control methods used.

Mayor Hindle inquired as to what had become of the idea to sponsor a contest for aquatic weed control machinery. The Chairman replied that this matter was also discussed with the Minster. He felt assured the contest would become a reality.

A revised copy of the 1977 provisional budget, attached to and forming part of these minutes, was presented to the Board. B.E. Marr: 1. A letter of March 22, 1977 from Mr. B.E. Marr relating to Skaha Lake lowering.

> Mr. Marr indicated that the only way Skaha Lake could be drawn down would be by reducing inflow from Okanagan Lake while maintaining present releases from Skaha Lake. Skaha Lake was presently at elevation 1107.89 and falling very slowly (about an inch per week). The Department of the Environment was proposing to allow this very slow drop to continue without altering the controlled flows into and out of Skaha Lake. The lake would therefore probably not fall below its normal lower operating limit of elevation 1107.6. It appears that irrigation is likely to start early this year - perhaps as early as mid-April, and this would mean restoring Skaha Lake to its normal level of about 1108.6 at that time.

The Secretary-Manager explained that since the time of the receipt of Mr. Marr's letter, several orchardists on Skaha Lake had developed a water shortage problem for orchard spraying. The orchardists in previous years, relied on a small stream for adequate water to fill spray tanks. However, the stream was not running this year and water was required from Skaha Lake. The lake had to be brought up to the normal operating level to provide water for these intakes.

> Director Gordon noted that docks are often built on the lake whether they are licensed or not. He felt that in many instances one common dock would be sufficient for several property owners, rather than having many small docks. Docks often atract weeds.

Director Clark indicated she would favour this application since it was a peculiar situation. This particular area of the lake was different that other areas in that the high water mark of the lake bordered abruptly to the property line and in some instances private properties were located out into existing water, as what had once been land had eroded into the lake.

The Secretary-Manager indicated that this was, in fact, a peculiar situation and there were not very many instances of this occurrence on the lake. High water mark ended abruptly against a cement wall on the property, therefore virtually no public land below high water mark.

Kenyon - Clark

Res. No. 47/77

That the application by Mr. A. Brown to construct a dock into Okanagan Lake be allowed.

CARRIED

Director Dooley suggested that should the District Land Manager wish a policy statement from the Water Board concerning docks and other structures into the foreshore, that a letter should be forwarded to the Board with this request.

Dooley - Stayberg

Res. No. 48/77

That the District Land Manager be asked to write a letter to the Okanagan Basin Water Board should he require the Board's views and recommendations on future docks to be constructed on Okanagan Lake.

CARRIED

The Board also suggested that the District Land Manager be asked for clarification concerning responsibility for inspection of structures on crown foreshore in Kelowna. There was some uncertainty as to whether Municipal Building Inspectors were required to inspect these structures.

Sanitary Sewer System for Okanagan Falls

K.D.O.S.: 4. Letter of March 28, 1977 from the Regional District of Okanagan-Similkameen concerning a proposed sanitary sewer system for Okanagan Falls.

> The letter was requesting a review by the Okanagan Basin Water Water Board of the sewer system so that a referendum could proceed. A copy of a letter dated March 25, 1977 from the Department of Municipal Affairs was attached, along with a copy of an engineering study with current cost estimates. The Department of Municipal Affairs indicated that since the Okanagan

Basin Water Board is the local authority under the Okanagan Basin Agreement; under the terms of the agreement the Board is to review all water quality projects.

Director Fleming questioned as to what criteria would be used in determining the end product from the Okanagan Falls waste treatment system and how would the Water Board decide if the 80% phosphorous removal guidelines of the Okanagan Basin Study are achieved.

The Secretary-Manager suggested that the final engineering design would show what the final system would be capable of achieving insofar as phosphorous removal is concerned. The Board would have to base its decision upon the final engineering design.

Director Kenyon questioned whether the system was extensive enough to cover the entire surrounding urban area of Okanagan Falls. Director Postill indicated that the community would have to bring the proposal to a referendum first, and the final engineering design could be achieved once a referendum is passed. The Water Board could give final approval to the system once the final design has been laid down.

Director Clark indicated that the Board should make it plain that part of its review did not include a technical assessment of the existing consultants report. Director Postill indicated this would not be necessary at this time since the community is simply asking for approval to go to a referendum. The final design criteria would determine whether the treatment plant meets the phosphorous removal specifications. The Water Board's decision would be based on the condition that the final engineering design meets standards requested by the Board. The Board is not making a technical decision at this time.

Colclough - Stayberg

Res. No. 49/77

That the application by Okanagan Falls to proceed with a referendum for a sanitary sewer system be approved, provided that the final engineering design guarantees that at least 80% phosphorous removal would be achieved by the sanitary sewer system when it is in operation.

CARRIED

The Chairman indicated that final construction must have capability for at least the tertiary stage of treatment before it would qualify for assistance under the Okanagan Basin Sewerage Facilities Assistance Formula.

Responsibility for the application of 2.4-D

R.D.C.O.: 5. Letter of April 5, 1977 from the Regional District of Central Okanagan concerning the responsibility for application of 2,4-D in Okanagan Lake.

The Chairman indicated there were several items dealing with this topic further in the agenda.

Director Colclough reported that the Regional District of Okanagan-Similkameen also agreed with the Regional Districts of North and Central Okanagan.

Director Gordon indicated that in reality there was very little interest earned, as funds were not received until late in the year. He suggested that the Board now give final consideration to the reserve fund by-law and requisition each Regional District for the amount outstanding in the reserve fund.

Fleming - Dooley

Res. No. 51/77

That the Okanagan Basin Water Board waive the request for payment of interest on sewerage facilities reserve funds held in 1976 by the Regional Districts, and that the Okanagan Basin Water Board now requisition these reserve funds from the Regional Districts, and further that these funds be forwarded to the Board within seven days of the date of requisition.

Director Clark asked that her objection to final reading of the By-law be recorded as she felt the By-law did not contain retroactive provisions for accumulating funds which had been earned in the year previous to the establishment of the By-law.

This correspondence was in reply to a letter of March 17, 1977 from the Water Board requesting comments on a draft copy of the basic principles of the Okanagan Basin Sewage Facilities Assistance Formula.

The Regional District of North Okanagan had unanimously adopted the formula as presented. They stressed that section 4 should be revised to include the alternative to increase the mill rate at a future date when necessary, rather than reducing the allocations in the event a basin-wide levy would exceed one mill. The Regional Board felt that a reduction of allocation would penalize latecomers who were contributors to the one mill from the outset.

The Regional District of Okanagan-Similkameen passed a resolution to the effect that the allocation of funds should be such that at no time would the basin-wide levy exceed one mill.

The Regional District of Central Okanagan agreed to accept the Okanagan Basin Sewerage Facilities Assistance Formula as presented by the Water Board but to include the one mill levy limitation. They also requested that the formula be reviewed in relation to funding once in each year.

Director Fleming indicated experience would show what mill rate would be adequate in the long run. He was reluctant to lock in the formula or freeze it at one mill. In the future it may be essential to raise the formula, say to one-and-a-half or two mills. As long as the one mill suffices, the Board should stay with it; but recognize that it may be neccesary to increase it.

Director Gordon expressed the same opinion. He felt that those municipalities coming into the formula at a later date would not benefit the same as those communities which had entered the formula at an early date. There would not be the same amount of funds left for those communities undertaking sewerage projects later in the time schedule. Director Day indicated if the formula were to exceed one mill at this time, then those people who are not being serviced by sewage systems would be reluctant to participate. He felt that a suitable compromise was that item number 5 in the formula be amended so that the financial provisions of the formula could be reviewed every year, but for the time being, the maximum should stay at one mill.

Director Kenyon agreed the one mill maximum should remain, but could be changed. By providing basin-wide sharing of sewage costs, there is a better case for financial assistance to be presented to the Federal and Provincial governments.

Director Fleming agreed that if the one mill could be kept in place and a provision be included in the formula for review each year, this could indicate a flexibility and an agreeable compromise.

Day - Kenyon

Res. No. 53/77

That item number 5 of the Okanagan Basin Sewerage Facilities Assistance Formula be amended to indicate that funding provisions of this formula would be reviewed annually, and that for the present time, the formula be contained so that a maximum of a one mill levy over the basin per year would fund the formula.

The Board was reminded that other provisions of the formula indicate that in order to qualify for assistance communities would have to provide tertiary treatment facilities. It was also suggested that in making payments out of the formula the Board should wait until after individual communities have received payment from the Sewerage Facilities Assistance Act. This would save on administrative costs and on determining the amount of payment. The Water Board would then merely pay 18/75ths of the amount paid by the Province.

The provisions of the formula as revised above are attached to and forms part of these minutes.

Other Business

Mtg. with Implementation Board

For the benefit of the press and public in attendance, the Chairman reported that the Okanagan Basin Water Board and the Implementation Board had met during the morning to review the responsibilities under the Okanagan Basin Implementation Agreement. The Water Board and the Implementation Board had agreed on the proposed program for implementation. Director Fleming further reported that the Water Board and the Implementation Board had dealt with two main classifications of recommendations - those dealing with sewerage facilities, and others dealing with recreation and flood plain zoning.

Liaison

Director Gordon recalled there was discussion concerning structuring Committees of liaison committees to implement some recommendations. The Chairman suggested that the topic of liaison committees be referred to the Regional Districts for further input. Existing organizational structures and facilities should be used as much as possible

> Director Colclough suggested that where certain recommendations pertain entirely to a localized area; for example, Mission Creek, these recommendations should be dealt with by the Regional District concerned.

Dooley - Gordon

Res. No. 54/77

That a letter be forwarded to each Regional District asking the Districts to discuss and comment upon how the liaison committees as suggested under the Okanagan Basin Implementation Agreement could best be established.

CARRIED

Septic Tank Reg.

Director Gordon indicated that septic tank regulations had also been discussed. He felt there should be a meeting between Health and Water Essources personnel, and Building Inspectors to see what could be done to implement recommendation 31 dealing with septic tanks.

The Chairman indicated that regulations had been sent to each Regional Board for review. This is presently being held at the technical level.

Dooley - Kenyon

Res. No. 55/77

That the Okanagan Basin Water Board request Regional Districts to have their building inspectors inspect septic tank fields and issue permits as required.

Director Clark requested that items 1 and 2 of the Committee meetind dealing with aquatic weed control be brought forward into open meeting.

It was suggested that item 2 dealing with an agreement should be left "In Committee" since the agreement had not been discussed publicly.

Clark - Gordon

Res. No. 56/77

That Item 1 scheduled for the "In Committee" meeting dealing with the second report of the Advisory Committee on the control of Eurasian water milfoil be brought into open meeting.

CARRIED

Second Interim Cttee -Aquatic Weed Control

Director Clark indicated that arrangements had previously been made that when the second interim report of the Advisory Committee Report of on the control of Eurasian water milfoil was to be released, it was Advisory to be released in the Valley by the three man committee which had studied the problem. She expressed disappointment that this had not been done. The Chairman indicated that it was not intended that public meetings be held at the time of the release but he expected that such meetings were now being arranged.

> Director Kenyon asked whether the Board was in favour of the contents of the report. Director Colclough indicated he did not see anything with which he disagreed. Director Kenyon mentioned that many of the recommendations of this report had been dealt with by the Board in the past. Director Clark was concerned that the report recommended a fairly high dosage of 2,4-D to be used on the City of Kelowna foreshore. She felt this would affect swimming and boating activity. She preferred that pilot projects be done outside of recreation areas.

Director Fleming mentioned that on Page 21 of the report, it indicated that the herbicide would not be used in swimming areas until test results had been compiled.

The Chairman reported the Province had indicated that 2,4-D would not be imposed upon any areas in the Valley where local residents or municipalities did not want it.

Director Clark indicated that testing in plots done last year were less than adequate and monitoring should be improved if further 2,4-D tests are to be done.

Director Fleming indicated that the Province was stepping into the aquatic weed program experimentally at first. The Board should support the Province. The only other alternative to herbicides would be to leave the problem for a natural disaster to eliminate the weeds. This was highly unlikely. He agreed the Province was entering this program very gingerly and scientifically and was concerned with health and environmental problems.

The Secretary-Manager indicated that on Page 20 of the report it appeared that spot control measures using herbicides would also be attempted.

Director Clark felt that applicants for the design of a new machine should be encouraged and she enquired whether this was still part of the program, or were local individuals being blocked. Secretary-Manager indicated that the Province was actively working on a contest. Director Day indicated that individuals developing new methods of weed control were reluctant to disclose the nature of the equipment as they wished to protect their patent rights. He agreed patent rights should be protected.

Patent Protection

The Chairman felt that before the Province could enter into a contract with anyone they would have to know whether the machine could do the job. The Provincial Government would establish quidelines which would have to be met.

That a letter be written to the Province requesting that the Province protect the patent rights of anyone applying to test or prove aquatic weed removal equipment.

CARRIED

Portable Equipment for Weed 'lean up

Director Gordon indicated that there are many residents along the lakeshore who would like to assist in clean up of small weed patches facing their properties; however, it is extremely difficult to accomplish anything without the assistance of some small type of high velocity water jet or a miniature suction dredge. These could easily be made available at a low cost. He suggested that the Water Board recommend the Province to look into this. The Secretary-Manager would write a letter to the Province with this suggestion.

R.D.C.O.: bilíty for the application of 2,4-D

In referring to the letter of April 5, 1977 from the Regional Responsi- District of Central Okanagan concerning responsibility for the application of 2,4-D and other herbicides, the Chairman indicated the Water Board was not nonpure White Non the overall program. OKANAGAN BASIN WATER BOARD BY-LAW NO. 1

Being a By-law to establish a Reserve Fund for the Okanagan Basin Water Board

WHEREAS Supplementary Letters Patent dated October 3, 1975, and December 22, 1976, issued to the Regional District of Central Okanagan, the Regional District of Okanagan-Similkameen provide that the Okanagan Basin Water Board may require that all participating regional districts contribute to the cost of sewerage facilities within the Okanagan Basin; which Basin is described in said letters patent, and

WHEREAS Supplementary Letters Patent dated December 22, 1976 issued to the Regional District of Central Okanagan, the Regional District of North Okanagan, and the Regional District of Okanagan-Similkameen, provide that the Okanagan Basin Water Board may, by by-law, establ sh a reserve fund, and

WHEREAS the provisions of Section 287 of the Municipal Act shall apply to the reserve fund, and

WHEREAS it is intended that the monies accrued to the reserve fund are to be used for the financial participation in the costs of providing sewage collection and treatment facilities in the Okanagan Basin;

NOW THEREFORE the Okanagan Basin Water Board in open meeting assembled enacts as follows:

- There shall be and is hereby established a reserve fund pursuant to the provisions of Section 287 of the Municipal Act, R.S.B.C. 1960, and amendments thereto, to be known as the "Sewerage Facilities Assistance Reserve Fund" and monies may from time to time be deposited to this fund in accordance with Letters Patent.
- 2. The monies set aside shall be deposited in a separate interest bearing account in a Chartered Bank or Credit Union, and until required to be used, shall be invested in the manner provided by the Municipal Act.

- 3. Any expenditure from the reserve fund shall only be used for contribution to the costs of providing sewage collection and treatment facilities in the Okanagan Basin and no expenditure for this purpose shall be made until a formula has been determined by the Okanagan Basin Water Board and approved by the Inspector of Municipalities.
- 4. This By-law may be cited as the "Okanagan Basin Water Board Sewerage Facilities Assistance Reserve Fund By-law No. 1, 1977".

OKANAGAN BASIN SEWERAGE FACILITIES ASSISTANCE FORMULA

Summary of the Main Concepts relating to the Okanagan Basin Sewerage Facilities Assistance Formula as agreed to by the Okanagan Basin Water Board on April 6, 1977:

- 1. The formula provides for the Okanagan Basin Water Board to pay 18% of net annual sewerage debt in excess of three mills to eligible communities within the Okanagan Basin. Sewerage facilities qualifying for funding would be identical to those qualifying under the Provincial Sewerage Facilities Assistance Act. Both plants and collection systems are included under this Act. Payment to a community by the Water Board would be calculated after payment has been made by the Province under the Act. The amount of payment by the Water Board would be in direct proportion to that paid by the Province, since the Water Board and the Province pay a fixed percentage of debt in excess of three mills. The Provincial share is 75% above three mills. The Water Board would pay $\frac{18}{75}$ ths or 24% of the amount the Province pays.
- 2. Community sewerage systems must be designed and operated to process effluent to at least a tertiary level (mechanically, chemically, by spray irrigation, exfiltration, or other accepted methods) of treatment to be eligible for funding. Communities presently not employing tertiary treatment would not be eligible for assistance under this formula until financing has been approved for construction of tertiary facilities.
- 3. The formula would be retroactive to include eligible debt incurred during 1976. This being the year when funds were first levied and held in reserve for this purpose.
- 4. Allocation of funds, to eligible communities, in the amount of 18% of net annual debt in excess of three mills will continue so long as the amount raised annually over the Basin does not exceed a levy of one mill. Should total allocations under this formula require more than a one mill levy over the Basin, the amounts allocated to communities would be reduced to a sum less than 18% in excess of three mills, so that in any event, a Basin wide levy would not exceed one mill annually.
- 5. Funding provisions of this formula would be reviewed annually.

The letter stated that there were an increasing number of requests from upland owners of waterfront property on Okanagan Lake for permission to build or repair docks, wharves and float to accommodate their boating requirements. The City of Kelowr have statutory authority to administer their building, electrical, water, and sewage by-laws within their municipal boundark which extends 600' from the natural boundary out into Okanagan Lake. This 600' gives validity to their by-laws only when the Minister of the Environment has granted permission to an upland owner to occupy the foreshore for uses such as fill, beach clean-up, tharf, dock or float construction, marina purposes, boat launching facilities, etc.

The Land Manager wished the Water Board to advise his office if they had any concerns, comments or policies regarding this type of activity on the crown foreshore.

In replying to Director Postill's concern regarding the jurisdiction of foreshore beyond 600' from the natural boundary, Director Fleming thought that this type of established jurisdiction would have to be applied for and a lease signed with the Provincial Government.

Director Boothe mentioned that the District of Summerland had signa a recreational foreshore lease with the Provincial Government for the Summerland foreshore area.

Director Colclough questioned as to who would have jurisdiction over foreshore that is not within a Municipality. The Secretary-Manager replied that the Provincial Government likely have regulations governing this.

b) A letter of April 28, 1977, from C.J. Sewell, City Clerk, City of Penticton.

This letter was concerning the Eurasian Watermilfoil in the area of the Skaha West Airport Beach. The Council of the City of Penticton is of the opinion that public use of this portion of Skaha Lake Beach should not be encouraged, and they therefore request that the Okanagan Basin Water Board take steps to eradicate the milfoil in that location either by harvesting or chemical means as quickly as possible. The only other alternative would be posting the beach so that the public would not be encouraged to use it, which they hoped would not be necessary to do, and that harvesting or eradication by chemical means take place as quickly as possible.

The Secretary-Manager explained that it had been initially planned to de-root weeds on Skaha Beach, but because of the sharp drop off, it would only be possible to get one half of the affected area. The only other alternative would be to use herbicides, or to harvest the top of the weeds off for the summer months. He indicated the City of Penticton's request has already been presented to the B.C. Aquatic Weed Committee.

Dr. Peter Newroth, Biologist, Provincial Government, was in attendance and spoke to the meeting concerning this matter. He indicated that a proposal to use 2,4-D in the Okanagan and Skaha Lake Marinas and Skaha Beach was before the B.C. Aquatic Weed Committee and the B.C. Interministerial Pesticide Committee.

Dr. Newroth indicated that there were two water intakes on the west side of Okanagan River. 2,4-D would be applied only if the water supplies to these intakes could be discontinued temporarily. This would be looked into more thoroughly if permission is granted from the B.C. Interministerial Pesticide Committee to apply 2,4-D. Since the City of Penticton has requested aquatic weed control using herbicides, this would hasten the decision of the B.C. Interministerial Pesticide Committee.

Hon. Romed LeBlanc: Aquatic Weed Control

Hon. Romeo 5. A letter of April 12, 1977 from The Honourable Romeo LeBlanc, LeBlanc: Minister of Fisheries and Environment Canada.

The letter indicated that the Ministry of Fisheries and Environment Canada contract studies of aquatic weeds to the private sector or to university specialists, and are currently sponsoring such research to an amount in excess of \$100,000. The actual operational control of the weed infestation of the Okanagan Lake System must be regarded as a matter of provincial responsibility. The senior provincial member of the Okanagan Basin Implementation Board has recently stated that the question of weed control should not be considered by the Federal - Provincial Board but is rather a matter for the Province alone. Accordingly, the Department of Fisheries and Environment Canada are unable to participate, as requested by the O.B.W.B. "in a comprehensive aquatic weed control program". If, however, the three-man Royal Commission appointed by the British Columbia Minister of the Environment reports that the milfoil problem is now truly national in scope, then the Okanagan Basin Implementation Board may wish to reconsider its position and look into the problem of weed removal under the general terms of the overall agreement.

The Chairman noted that Mr. Whittaker, MP, Okanagan Boundary, and Mr. Jarvis, Opposition Critic, have done a good job in bringing this matter to the attention of the Federal Government.

The Secretary-Manager indicated that the three-man Advisory Committee have mentioned in the first Interim Report a major area of consideration would be enlisting the assistance of the national government in dealing with the problem which may soon become an international situation.

The Chairman suggested a letter be written to the Okanagan Basin Implementation Board requesting them to consider their position concerning Federal assistance in an aquatic weed control program based on the evidence in the three-man advisory committee's report and the involvement of the Provincial Government in the new aquatic weed control program in the Okanagan Valley. The problem is now considered to be national in scope.

Agreement for an Okanagan Basin Aquatic Weed Removal Program

Aquatic Weed Agreement A letter of May 2, 1977 from Mr. B.E. Marr, Deputy Minister of the Environment, along with the agreement for an Okanagan Basin Aquatic Weed Removal Program were reviewed by the Board. The agreement is attached to and is a part of these minutes.

The Secretary-Manager, in referring to the second paragraph of Mr. Marr's letter concerning interim financing, indicated that there appeared to be some misunderstanding as to payment of interest costs on funds borrowed to purchase materials and equipment. It had been indicated to the Province that interest costs could be claimed by the Water Board even though reimbursement by the Province is made within 90 days.

In responding to Director Boothe's concern as to who would be making the final decision on the type of weed program, reference was made to Paragraph (2. a.i) indicating Provincial responsibility in this regard. It was also indicated that if a local municipality does not want the program it would not have to accept it. Director Fleming indicated there would be consultation before decisions are reached. Director Kenyon felt that individual communities should not be able to scuttle the whole program.

The Secretary-Manager indicated that before the Province could apply herbicides, the procedure requires that each site be reviewed by the B.C. Aquatic Weed Committee and the B.C. Interministerial Pesticide Committee.

Director Fleming felt there should be provisions for control on agricultural and forestry practices to curtail silt loads.

AGREEMENT

for

OKANAGAN BASIN AQUATIC WEED REMOVAL PROGRAM

(1) GENERAL

THIS AGREEMENT between the GOVERNMENT OF THE PROVINCE OF BRITISH COLUMBIA represented by the Minister of the Environment and the OKANAGAN BASIN WATER BOARD represented by the Chairman provides for the implementation of an aquatic weed removal program in the Okanagan Basin of British Columbia.

(2) RESPONSIBILITIES

- (a) The Government of the Province of British Columbia shall:
 - (i) assume overall responsibility for the design, co-ordination and implementation of the weed control program in concert with a continuing assessment of the problem and in consideration of local needs as expressed through the Water Board and municipal governments.
 - (ii) reimburse the Water Board for all costs incurred in connection with program implementation except administration costs as described in Clause 2(b). All equipment and materials purchased will become the property of the Province.
 - (iii) undertake an information program, including all press releases, to advise the public of planned measures and program progress and effectiveness.
- (b) The Okanagan Basin Water Board shall provide and pay for salaries of a maximum of an average of two staff per annum who would provide administrative services toward the program. These services would include: purchases of equipment and materials, awarding and payment of contracts (but not including specifications, inspection and supervision of contracts), hiring of a work force, payroll administration, program accounting, and arranging for local support services. All expenditures under this function, except for salaries and office expenses exclusive of space rental for the two administrative staff, will be fully reimbursed by the Province within 60 to 90 days of being appropriately requisitioned by the Water Board.

Administrative services provided by the Water Board shall apply to the direct weed control operation and not to support programs such as long-term monitoring and research, and mapping.

(3) STEERING COMMITTEE

- (a) Each party to this Agreement shall appoint one member to a joint steering committee.
- (b) The member representing the Okanagan Basin Water Board shall provide technical guidance based on past weed removal experience. This member shall also provide liaison with the administrative functions undertaken by the Water Board.
- (c) The member representing the Minister of the Environment shall advise on program priorities, progress and effectiveness, and, take under advisement matters related to local needs received from the Water Board and municipal governments.

(4) TERM OF AGREEMENT

This Agreement supersodes the March 23, 1976 agreement between the two parties and shall extend from the date of signing to March 31, 1980, except that it may be extended further upon mutual agreement by both parties.

Penticton, Osoyoos, Vernon and Coldstream were the only communities with tertiary treatment to date; consequently, these would be the only ones presently eligible for assistance.

Director Postill presented a resolution relating to financing of tertiary treatment costs, which was adopted during a meeting of the Regional Board of the Regional District of North Okanagan held May 25, 1977. In referring to item 4, S. Buckler enquired as to what effluent Naramata was disposing. Director Colclough replied that there was no sewage plant in Naramata. The groundwater survey was requested to examine the problem of seepage from septic tanks. Since the Okanagan Basin Implementation Board indicated they have no capability under the terms of the agreement to carry out any program involving groundwater, Director Colclough informed that another possibility would be explored.

Chart -Function Liaison

Organiza- Director Colclough presented a proposed organization chart showing tion a structure for the function of the Liaison Committee. He indicated the Liaison Committee should consist of one member of the Water Board from each Regional District, along with the Secretary-Manager of the Water Board and Mr. Thomson, coordinator of the implementation program. Director Colclough offerred to represent the Regional Committee District of Okanagan-Similkameen. Mr. Thomson felt that the Liaison Committee should represent the Okanagan Basin Water Board rather than Technical Planning Committees. He felt that members of this committee should have some continuity from year to year. The Secretary-Manager, in referring to letters patent, indicated the Liaison Committee as presently proposed deviated somewhat from the Technical Liaison Committee described in Letters Patent. However, this should not pose a major problem. The proposed Liaison Committee would be closely linked to Technical Planning Committees.

> Director Postill expressed concern over uncertainties as to which agency would finally have the authority in determining whether or not a particular application for sewage treatment was necessary. The Chairman replied that it was his understanding that individual communities would apply to the Okanagan Basin Water Board through the Implementation Board. Mr. Thomson indicated that the Water Board and the Implementation Board would review the applications and C.M.H.C., the Department of Municipal Affairs, and the Pollution Control Branch would have the final say.

> The Secretary-Manager indicated the Implementation Board would likely review sewage programs to see that they fit into the overall scheme in Basin-wide waste treatment. They are then likely to make recommendations to C.M.H.C. and the Department of Municipal Affairs relative to financing.

The Chairman indicated the authority of the Implementation Board was mainly in dealing with recommendations of the Okanagan Basin Study. The Water Board is not a signor of the Implementation Agreement and its role was likely to be advisory.

Mr. Thomson informed that the overall plan for sewage treatment facilities in the Okanagan Basin is presently in the draft stage and was of interest to the Implementation Board. It would be up to the Water Board to deal with each community individually. It was the Chairman's understanding that the Technical Committee would advise the Water Board on suggested sewage works.

Director Clark enquired as to the composition of the Technical Planning Committee. Director Colclough replied that Technical Planning Committee members would be the same as presently existing, however, other technical experts could be called upon by these committees as required. Recommendations relating to local problems only would be given attention by the local Technical Planning Committee.

Director Kenyon left the Board room at 3:10 p.m. He resumed his seat at the Board room table at 3:11 p.m.

The City of Penticton was therefore requesting payment of \$11,034.80 by the Okanagan Basin Water Board for the year 1976. The City enclosed a copy of their grant application, made under the Sewerage Facilities Assistance Act, along with proof of payment. A separate letter certifying that the City has been treating all effluent to a tertiary level was also enclosed.

The Secretary-Manager indicated that since the Water Board Finance Formula was contingent upon tertiary treatment, certification of tertiary treatment was requested. Penticton is the only City to qualify retroactively to 1976. Vernon, Coldstream and Osoyoos would qualify for 1977 funding.

Director Colclough mentioned that the Liaison Committee had met prior to the Water Board, and it was the consensus of the Committee that municipalities be requested to obtain certification of tertiary treatment from the Pollution Control Branch rather than from the municipality itself.

Following this, they could propose an equitable cost sharing for joint consideration.

The Secretary-Manager explained that at the time the agreement was drawn it was difficult to determine the amount of interest costs; therefore provision was made to recover excessive costs. He suggested that interest charges be reviewed at the end of the year and appropriate reimbursement be negotiated.

Director Boothe enquired concerning the Steering Committee. The Secretary-Manager indicated the Steering Committee is referred to in the agreement for an aquatic weed removal program. The Committee would be composed of a member representing the Okanagan Basin Water Board and a member representing the Ministry of Environment. The Water Board has not appointed a member to the Steering Committee.

A letter dated July 7, 1977 from G. Simmons, Chairman, Implementation Board was received.

Mr. Simmons indicated the proposal for waste treatment at Okanagan Falls was reviewed by the Okanagan Basin Implementation Board. The Implementation Board noted that the proposals for Okanagan Falls as set out in the engineering report, envisage treatment by use of an oxidation ditch process, with disposal either by way of spray irrigation, infiltration, or a combination of both. Providing effluent disposal is carried out as so described, the Board considers that the proposals would conform with the overall interest of the Federal-Provincial Agreement which is to, inter alia, encourage the development of waste treatment systems which would lead to the improvement of water quality in the Okanagan River system.

The letter also noted that proposals for waste treatment by communities in the Okanagan Valley are to be a part of the plan to be developed by the regional authority, (Okanagan Basin Water Board), as indicated in the Implementation Agreement.

The Secretary-Manager indicated that he had been working on this plan with a member of Environment Canada and that it was now a matter of editing and typing the report.

acuatic weed removal equipment

Disposal of A list of equipment that has been acquired by the Province and the Okanagan Basin Water Board since 1973 was presented to the Board. This equipment included:

- 1 used H650 Aquamarine Harvester,
- 1 used 1970 Ford LN750 truck equipped with metal box and hoist,
- 1 used transport trailer for movement of harvester, and
- 1 used Bombardier.

It was recommended that exclusive ownership of the above equipment except for the used Bombardier, be assumed by the Province at a nominal consideration of \$1.00. The City of Kelowna have used the Bombardier unit in the past, and would be interested in having the equipment retained.

He indicated use of 2,4-D so far was on an experimental basis and only about 12 acres have been treated. Environmental groups had given the impression that large amounts had been used on large acreages. He felt this erroneous publicity was damaging.

Director Kenyon felt it important now to show the monitoring results to the public, indicating the safety of 2,4-D.

Director Colclough indicated that Dr. Clark of the South Okanagan Health Unit had asked for an exchange of monitoring results on the current herbicide application for control of aquatic weeds. It was indicated that the Province was doing all the monitoring and had already made the information available to the Press. The results could be obtained very easily from the Water Resources Service.

B. Marr: Aquatic Plant Management Program

The summary report of proposed waste treatment and collection facilities in the Okanagan Basin prepared by the Secretary Manager and Ken Cooper of Environment Canada had been forwarded to the Water Board members for their perusal.

Facilities, Director Boothe enquired how the projected costs for Summerland Okanagan were derived. The Secretary-Manager explained that since no feasibility studies have been done in Summerland, and since sewerage facilities are not planned for the near future, figures were dervied using feasibility studies for similar areas as comparisons. Costs for Summerland, Naramata and Peachland are shown separately at the end of the report.

Director Clark, in referring to notes of the Liaison Committee noted that the report would be circulated to Regional Districts and Municipalities for further recommendations. She suggested that municipalities indicate if additional figures could be useful in the report.

The Secretary-Manager explained the summary report was only a draft for long term planning purposes only. The Chairman concurred that figures for most of the Municipalities are estimates. CMHC and the Province (Sewerage Facilities Assistance Act) also required these figures to plan future grants. The Implementation Board would review costs to see if they are excessive and could recommend additional funding if necessary. Municipalities required to construct sewage collection systems and tertiary treatment systems all in one phase will face a high cost burden.

Director Fleming indicated that the resolution adopted by the Regional District of North Okanagan, and other communities of the Basin, requesting the Provincial and Federal Governments to recognize by special funding programs the need for additional financial assistance wherever tertiary treatment of sewage is undertaken, would be debated at the U.B.C.M. convention to be held September 21 - 23. He indicated that the summary report showing costs of proposed waste treatment and collection facilities in the Okanagan Basin was a valuable supporting document for the convention. The communities of the Basin should unite during the convention in support of the resolution for additional funding.

Aquatic Weeds: Yacht Basin

Vernon Cr. Director Fleming reported major work being undertaken in Vernon Construc- Creek near the outlet of Kalamalka Lake. He thought that the Board tion near should look into this.

Director Boothe reported the Yacht Club Basin in Summerland was heavily infested with milfoil. The Secretary-Manager suggested that a specific request by letter from Summerland for weed eradication in that area be made directly to the Province or through the Summerland Water Board.

> Director Fleming enquired as to the total acreage of weeds treated with 2,4-D to date. The Secretary-Manager replied that approximately 23 acres have been treated to date. The total surface area of Okanagan Mainstem Lakes is approximately 100,000 acres. Director Fleming drew attention to the relatively small area of water affected by 2,4-D use.

> Director Colclough also pointed out the high per capita annual cost of sewerage facilities to communities such as Okanagan Landing and Osoyoos. Perhaps alternatives which could reduce these costs should be researched. Director Fleming felt there was a need to arrive at a median per capita annual cost to each community to justify subsidization.

Marking Weed Beds

Director Kenyon submitted a letter from Mrs. D. Anderson of Penticton. She urged that areas infested by milfoil be clearly marked to prevent boaters encroaching into them. The Secretary-Manager would encourage the Manager of the weed control program to mark aquatic weed beds.

The Secretary-Manager mentioned that the Technical Planning Committee of the Regional District of Central Okanagan had met at an earlier date to review the proposed Okanagan Basin Septic Tank Regulations. The Water Board was still waiting for the recommendations from this meeting. Director Colclough suggested that this information from the meeting be relayed to the Regional District of Okanagan-Similka meen before their meeting on the 29th.

The meeting adjourned on a motion by S. Fleming, seconded by A. Kenyon at 3:20 p.m.
