4. STAFF REPORTS

4.1 Executive Director Report

Dr. Sears reported on a meeting between herself, OBWB Chair McKortoff, Dir. Derickson, ONA technical observer to the board Tessa Terbasket, and ONA Natural Resources Manager Cailyn Glasser. The meeting was to discuss ways to strengthen the relationship between the Water Board and the Syilx nation around mutual water goals. Dir. Derickson noted the importance of the meeting in addressing water issues and in the journey of reconciliation.

The board was updated on a roundtable discussion on water between various water organizations and NGOs with B.C. Minister of State Nathan Cullen.

4.2 Operations and Grants Manager

Mr. Littley noted the B.C. government’s response to the OBWB’s March 4th letter with calls to action on invasive mussels. While the province has said it is working on “pull-the-plug” legislation there was no immediate commitment for additional outreach funding for invasive species groups, or resources to local governments to conduct vulnerability assessments. It was suggested that OBWB may want to ask partners to enhance these last two items.

There was general agreement for working more closely with partners. Dir. Derickson added that an introduction of invasive mussels would devastate Syilx culture and that ONA is looking forward to working with OBWB on this issue. Dirs. Cumming and Baker noted the significant role that could be played by promoting social responsibility among watercraft owners. Ms. Jackson noted that social responsibility is a key element of the Don’t Move A Mussel campaign being developed with Habit Creations Marketing.

4.3 Communications Director Report

Ms. Jackson provided an update on the “Make Water Work” (MWW) campaign, now in it’s 10th year, noting participation from local governments throughout the valley. Plans are underway for a launch similar to last year, with mayors and elected officials creating short MWW pledge videos for social media. Further details will be provided in the next few weeks.
